PREFACE

In 2021, in a loss for the local archaeological community as well as for her family and friends, Lou Schuyler went from apparent good health to dying of cancer. Before then, however, she completed a manuscript summarizing the room excavations at Tijeras Pueblo. Like all her work for this series, the Tijeras room descriptions reflect her ability to organize information from disparate and sometimes conflicting sources, and to present that information in a coherent narrative.

During the editorial process, Lou broke the manuscript into multiple parts. She had not reviewed the first edited draft of Part 5 by the time she became too ill to proceed. Jean Ballagh, an outstanding editor and frequent contributor to this series, volunteered to review that draft. Changes were kept to a minimum, however. To provide two examples, Lou's initial drafts used "fire pit" or "hearth" as those words appeared in field records, and did the same for "matrix" versus "fill"; in Part 5 we made no attempt to modify such terms in the name of greater precision. Also, neither Jean nor I know the subject matter the way Lou did. The reader is warned that inconsistencies and mistakes may have slipped through that would have been eliminated, had Lou lived a few months longer.

Lou had a strong sense of the proper order of presentation of the Tijeras room descriptions. I asked her to explain her approach; her answer appears as the final paragraph of Chapter 1.

Chapter 1

INTRODUCTION TO PART 5




Figure 1.1. Map of the main portion of Tijeras Pueblo, showing construction periods and the numbered rooms. Prepared by Nicholas E. Damp; courtesy of Linda Cordell.

This volume is a continuation of the descriptive report and finding guide for Tijeras Pueblo room excavations during the 1970s. Parts 1 through 4 of this report (Schuyler 2020a, 2020b, 2021a, 2021b) describe Room Blocks 1–3. This volume describes Room Blocks 5, 6, and 8 and the large detached kiva, shown in Figure 1.1. The report closes with a summary based on the descriptions in Parts 1 through 5.

The reader is referred to the Preface, Acknowledgements, and Chapter 1 in Part 1 of this report for a complete introduction to the study and for an explanation of methods followed. The appendices will appear in the final part of this report. Table 5.1 identifies the rooms discussed in Part 5. In the chapters, rooms are sometimes presented in the most logical order rather than in sequence by room number.

In certain chapters, only a few rooms are covered because they were excavated together or because the excavations interfered with each other, and what was found in one room is helpful in understanding what was found in another. In these chapters, rooms are discussed in the order that explains their relationships rather than in numerical order. Otherwise, rooms are covered in numerical order as their excavations were mostly or entirely unaffected by excavations in neighboring rooms.

Chapter 2

ROOM BLOCK 5, ROOMS 14 AND 6




Figure 2.1. Locations of Rooms 6 and 14 in Room Block 5. Source: Cat. No. 2005.25.15165.

Rooms 6 and 14 were both excavated in 1971. Excavation in Room 14 continued in 1972. Figure 2.1 shows the two rooms relative to adjoining rooms in the room block.

Room 14

1971 Excavation




Figure 2.2. Plan and profile of Room 14. Source: Cat. No. 2006.1.3.

James Judge led the 1971 excavation that identified this room, which is shown in Figure 2.2. Seven student notebooks (Cat. Nos. 79.84.36, .42, .43, .46, .47, .51, .63) describe work in the room from July 7 through July 22.

Data from Field Forms (Cat. No. 79.84.4)

Room Data Sheet. The sub-datum for this room was at 100S/100E, at 11.42 feet BD. Four adobe walls were identified (Table 2.1) and three floors were excavated.

The depths of the corners were recorded as 3.58 feet BSD (northeast), 3.0 feet BSD (southeast), 1.5 feet BSD (southwest), and 1.3 feet (northwest).

The fill contained adobe chunks, trash, and two ash lenses, and was "clayey" below the second floor (4B). The lowest floor was not reached in 1971.

After excavating the first floor (4A), the east half of the room was taken down to the first level of fill below the first floor (5A). The east wall was rock-faced for the top 6 inches. After removing the facing, an interior adobe wall was identified.

Grid Level Records. The east wall of Room 14 was the west wall of Room 6. While excavating the first floor of Room 14, the students found a hole in the east wall, above the floor. The hole extended into Room 6 and may have led to the ventilator shaft on the Room 6 side of the common wall.

A diagram showed Feature 1 (F1), a stone-lined hearth, at the middle of the north wall.

Feature Forms. A form for a hearth (F1) placed it at 12.92 feet BD at grid location 101.3–100S/084–085.8E, 1 to 1.3 feet from the north wall. The hearth measured 1.8 feet wide and 0.25 foot deep and was filled with packed dirt and a small amount of ash and charcoal. The hearth was associated with the first floor (4A).

A form describes the hole in the east wall that led to the ventilator shaft in Room 6. The hole had been cut through the wall and later was filled in.

Observations from Notebooks

The room was first identified in grid unit 110S/080E (Cat. Nos. 79.84.42 and .63). The south adobe wall was plastered adobe (Cat. No. 79.84.42).

A slab-lined hearth (F1), surrounded by adobe that had fired red, was found at the north wall. The hearth did not appear to be on a floor (Cat. Nos. 79.84.43 and .63). At first the hearth was associated with the first level fill (2A); later it was associated with the first floor (4A) (Cat. No. 79.84.42).

In the east half of the room, the students found a wall behind a rock-faced wall (Cat. No. 79.84.42). They cleared the east half of the room to the first level of fill below the first floor (5A)

and found a second ("inner") east wall after removing the rock facing from the first identified east wall (Cat. No. 79.84.43).

The students dug a test pit in the northeast quadrant of the room (Cat. No. 79.84.51).

Summary of Excavation by Level

1972 Excavation

James Judge led the 1972 excavation of Room 14. Four student notebooks (Cat. Nos. 79.84.72, .75, .79, and .91A) describe work in the room from June 13 through June 20.

Data from Field Forms (Cat. No. 79.84.4)

Room Data Sheet. I found a second room data sheet and based on the students who completed it, I assume that it was created in 1972. The wall measurements (Table 2.3) and other data on the sheet differ from those reported in 1971 (Table 2.3).

The depths of the corners were recorded as 2.9 feet BSD (northeast and southeast), 2.85 feet BSD (southwest), and 2.7 feet (northwest).

The fill was loose dirt, charcoal, and adobe chunks. In 1971 the function of the room was uncertain, but in 1972 it was identified as a habitation room. Again, the lowest floor was not reached.

Feature 2A (F2A) was a hearth associated with the second floor (4B) and with the level of fill above it (5C). A second hearth (F5) was associated with the third floor (4C).

Grid Level Records. The grid level record for the first level of fill below the first floor (5A) places the sub-datum at 100S/080E, which differs from the value provided for the 1971 sub-datum.

In discussing the first level fill below the first floor (5A), the students thought that the rocks found below 5A were roof fall. They indicated that the west half of the room should be recorded as 5B (second level of fill below 4A), which did not necessarily correspond to the Level 5B excavated in the room's eastern portion in 1971.

Feature Forms. Feature 3 (F3) was a wall of sandstone slabs and mud, found 2 feet deep. Feature 3 was located at 0.05 foot BSD in grid location 106–105S/081.5–078E, and was 4 feet long.

Feature 2A (F2A), associated with the second floor (4B), was located at 2.6 feet BSD at grid location 104.5S/085.2E. Feature 2A was a slab-lined pit surrounded by burned adobe. The

feature measured 1.9 by 1.6 feet by 0.9 foot deep and was filled with dirt, ash, and charcoal. Its slab bottom lay directly over a second fire pit.

Feature 5 (F5) was associated with the third floor (4C). The feature was located at 3.0 feet BSD at grid location 104.5S/055.2E, directly below F2A. F5 had slab-lined sides and bottom, with some rocks missing. It measured 1.8 by 1.5 feet by 0.6 foot deep and was filled with ash, clay and charcoal.

Summary of Excavation by Level

1974 Summary of Judge Excavations

Data from Field Form (Cat. No. 79.84.278A)

This form places the room in grid unit 100S/080E. The students dug down to the third floor (4C), to a depth of 2.8 feet BSD, with a subfloor test extending to 2.9 feet BSD. The room function is listed as "habitation/ceremonial." (The 1971 forms include a discussion about whether the "possible" ventilator hole extending through the east wall, into Room 6, meant that Room 14 was a kiva. The 1972 field form states that Room 14 was used for habitation.)

Table 2.5 summarizes the floor descriptions. The form refers to the "sub floor test" below the third floor (4C) as revealing a possible additional floor at 2.9 feet BSD. The ventilator in Room 6's fill was associated with Room 14's second floor (4B).

The Maxwell Museum archives include six photographs of Room 14 (Table A.1). Figure 2.3 shows the fire pit (F2A) on the second floor (4B) and Figure 2.4 shows the fire pit (F5) associated with the third floor (4C).

Room 14 appears on maps created in 1971 and from 1973 through 1976. All of the maps provide plan views. One 1971 map (Cat. No. 2006.1.13) also provides a profile (Table A.2).

Room 6

1971 Excavation




Figure 2.5. Plan and profile of Room 6. Source: Cat. No. 2006.1.13.

James Judge led the 1971 excavation of Room 6 which is shown in Figure 2.5. The room had three adobe walls, a masonry wall, a plaster floor, and a sealed doorway. Nine student notebooks (Cat. Nos. 79.84.37, .42, .43, .46–.48, .51, .62, and .63) describe work in the room from June 22 through July 22.

Data from Field Forms (Cat. No. 79.84.2)

Room Data Sheet. The sub-datum for this habitation room was at 100S/100E, at 11.68 feet BD.

The room fill included trash and adobe chunks. Only the east wall was masonry; the other three were adobe (Table 2.7). Doorways were found in the east and south walls, and the data sheet mentions a possible viga socket in the north wall. The doorway in the east wall had been sealed.

The room corner depths were 2.5 feet BSD (northeast and southwest), 2.3 feet BSD (southeast), and 3.3 feet BSD (northwest). The plaster floor (4A), which was 0.5 foot (inch?) thick, was located at 3.27 feet BSD. The floor was associated with a fire pit and a wall cist. Only one floor was found. The excavation did not reach sterile.

Six features were reported; two fire pits (F1, F2), a dog burial (F3), a possible ventilator shaft (F4) associated with Room 14 (the room west of Room 6), and the fire pit (F5) and wall cist (F6) associated with the first floor (4A).

Grid Level Forms. A form for the first (only) floor (4A) indicated that four of the features (F3, the dog burial; F4, the ventilator shaft associated with Room 14; F5, the fire pit; and F6, the wall niche/cyst) were found on the floor. A note indicated that Test 3 (T3) might have exposed a viga "hole" (socket) in the room's north wall.

Feature Forms. F1 was most likely a grinding "box" (bin?) instead of a fire pit as indicated on the Room Data Sheet. The form for F1 describes charcoal from the top of the surface dirt and an ash lens and burned adobe extending down about 0.2 foot in the northwest corner of the room. A second (?) gray ash lens with a flat-lying rock slab at its base extended down about 0.3 foot and extended horizontally over most of the feature. The slab, found in the first level of fill (2A), lay over charcoal, had been cemented in with adobe, and lay over chunky adobe fill that included charcoal and roots (similar to the fill in the rest of the room). The grinding "box" (F1) measured 1.6 by 1.6 feet by 1.4 to 1.5 feet deep. F1 was associated with the fire pit (F2) and with stones above the dog burial (F3).

F2 was a possible fire pit located 0.5 foot below the surface and measuring 1.6 by 1.3 feet by 0.1 foot deep. F2 was on the same level as, and was associated with, the possible grinding "box" (F1) and with stones above the dog burial (F3). Two ash lenses overlay the stones and a small area of floor at the level of the stones. As the stones were removed, more floor was uncovered, as it had taken the shape of the rocks. An ash lens was also found under the top rocks.

F4 was a possible ventilator shaft that appeared to be associated with Room 14. The horizontal part of the shaft included a hole in the west wall of Room 6. The shaft measured 2.1 by 1.4 feet across and was 2.3 feet deep.

F5 was a possible adobe-lined fire pit at the north wall of the room. The feature measured 2.5 by 1.75 feet across and included stones resting on the floor (4A). The fill of F5 was ash, charcoal, adobe, and loose stones.

F6 was a niche or cyst in the north wall of the room. The cyst's opening was sealed with stacked tabular sandstone, with a large slab lying directly on the cyst's floor. Pieces of rock, mortared with adobe, were plastered over to bring the former opening flush with the wall. A plastered floor was built in the cist 0.6 foot above the floor.

Burial Form. Burial (B1) was a dog wrapped in cloth, facing west and placed on an adobe bed in a burial pit. Rocks were placed at the top of the pit, directly above the dog. A few sherds were found in the burial pit fill.

Observations from Notebooks

The students dug a test trench in the southwest corner of the room that is referred to as Test Pit 1 (T1) by other excavators (Cat. Nos. 79.84.42, .43, and .62), and found a floor about 1 foot down. Test pit 2 (T2) was also described as located in the southwest corner of the room (Cat. No. 79.84.42). Artifacts in the collections were identified as being recovered from both T1 and T2, as well as from a test pit without an identifying number (Table 2.9, below).

The actual position of the fire pit (F2) in the south part of the room is not clear but it may have been associated with an unidentified floor. One excavator (Cat. No. 79.84.62) reported finding remains of a floor, below the fire pit (F2), at the same level as the rocks. Two students (Cat. Nos. 79.84.42 and .43) reported finding possible remains of a floor on top of F2. A fourth student (Cat. No. 79.84.63) reported finding part of a floor at the edge of F2 and that flat stones lying on F2 may have pressed into the floor while it was wet. A fifth student (Cat. No. 79.84.46) reported that after F2 was removed, a possible floor remnant was found at the "top level."

The students found holes left from an earlier dig (Cat. No. 79.84.42).

The students dug through the first level of roof fall (level 3A) and found evidence of a floor only around the grinding "box" (F1) and the fire pit (F2) (Cat. No. 79.84.46). While digging the test trench in the southwest corner of the room, the students found evidence of a floor (Cat. No. 79.84.63).

The room walls were described as adobe, with rock walls built close to (but not conforming with) the adobe walls (Cat. No. 79.84.46). The masonry in the <u>east and west</u> walls was large chunks of sandstone and limestone, "poorly cemented"; the north and south walls were adobe (Cat. No. 79.84.48).

After clearing the first floor (4A), the students found decayed plant remains in the northeast quadrant of the room that may have been a layer of corn husks (Cat. No. 79.84.48).

The dog burial was found about 2 feet below the surface, just under a large group of rocks. The boundary between the adobe chunk fill of the room and the burial pit was clearly visible. The bottom of the burial pit was adobe lined. The pit contained the completely articulated skeleton of a dog (about the size of a collie or German shepherd), surrounded with the remains of vegetation or fur, on an adobe bed (Cat. Nos. 79.84.37, .46, .48). The dog was wrapped in cloth, which left

an imprint on the adobe base. When the students removed the dog remains, they found a .22 caliber bullet (Cat. Nos. 79.84.37, .48, and .63), suggesting that the dog burial was recent.

The students described F4 as a ventilator contiguous with the floor level. In part the ventilator consisted of a hole extending under the west wall of Room 6 into Room 14 (Cat. No. 79.84.46).

A cist (F6) was found in the north wall (Cat. No. 79.84.46)

The room was backfilled on the last day of excavation (Cat. No. 79.84.51).

1974 Summary of Judge Excavation

Data from Field Form (Cat. No. 79.84.278A)

The room was located in grid unit 110S/090E. The room was "possibly ceremonial," based on the niche and fire pit associated with the first floor (4A). Excavated levels included the first and second surface levels (1A, 1B), which were not mentioned on the 1971 forms. The depth of the 1974 excavation is listed as 3.3 feet BSD. A subfloor test was made against the middle of the north wall, extending to 3.9 feet BSD. This was below the first (only) floor (4A) but sterile was not reached.

One floor (4A) was identified; it measured about 11.3 by 6.1 feet and extended to a depth of 3.3 feet. The room had adobe and masonry walls. The 1971 forms indicate that the floor was plaster, but this form identifies it as adobe (given the use of adobe plaster, the distinction may mean very little). Features mentioned include the fire pit and the wall niche at the 1st floor (4A) and the ventilator on the west side of the room. The describes an opening going through a "plastered up" doorway into Room 14, which would mean that the door was on the room's west wall (the 1971 form refers to only one "sealed" doorway located in the east wall). The room fill is described as "erosional," and the room as "more rectangular" than adjacent rooms.

Artifacts, Photographs, and Maps in the Collections

Table 2.9 summarizes the artifacts from Room 6 in the Maxwell Museum collections. None of the artifacts are from the first and second surface levels (1A, 1B).

Room 6 appears on maps created in 1971 and from 1973 through 1976. All of the maps provide plan views. One 1971 map (Cat. No. 2006.1.13) provides a profile (Table A.2).




Figure 2.5. Room 6, Feature 1 (the grinding "box"). Source: Cat. No. 80.24.538A

Chapter 3

ROOM BLOCK 5, ROOMS 98, 97, 99, AND 100




Figure 3.1. Room 100, showing excavation work just south (right) of the room. Source: Cat. No. 80.33.91A

Rooms 97–100 in Room Block 5 were studied in 1973. James Judge decided that Room 99 was not a room. Figure 1.1 shows the location of Rooms 98–100. None of maps in the collections shows these rooms in detail, or in some cases at all. Figure 3.1 is a photograph of Room 100 that suggests that excavations took place just south of it. Similarly, Figure 2.1 shows Room 100 plus a hachured area indicating excavation work south of that room.

Room 98

1973 Excavation

James Judge led the 1973 excavation that identified this room. Four student notebooks (Cat. Nos. 79.84.109, .119, .120, and .122) describe work in the room from June 20 through July 4.

Data from Field Forms (Cat. No. 81.25.31)

The sub-datum for this room was at 140S/090E, without a stated vertical relationship to the datum.

Grid Level Records. A diagram shows two adjoining test pits, Test Pit 1 (T1) and Test Pit 2 (T2).

A diagram shows that a section of ash lens was removed from a depression in Test Pit 1 (T1) at 3.48 feet BSD, and that a patch of white ash was found at 2.2 feet BSD in Test Pit 2 (T2). Test Pit 1 (T1) abutted a pedestal, with backdirt beyond the pedestal.

Test Pits 1 and 2 (T1, T2) each exposed sand and ash lenses.

A different form refers to the pit identified as Feature 1 (F1) as an ash pit at the fourth level of fill (2D). The form notes that the room's west wall did not appear to have any footings, but rested on what may have been a continuation of the floor in Room 97, and that Room 98's masonry east wall appeared to slant down to the west, where it bowed and was stepped (i.e., the highest stones were set farther back into the hill than the stones below).

Feature Forms. A pit was designated Feature 1 (F1) and associated with a possible floor at the fourth level of fill (2D). The center of the pit was located at 4.1 feet BSD, 3.8 feet below the surface, at grid location146.2S/098.9E. The pit (F1) was filled with ash, bone, adobe chunks, sherds, and burned rocks, and measured 2.8 feet "at the front," 1.15 feet deep on its east side, and 0.95 foot deep on its west side. A diagram shows F1 as lying near a masonry wall; as filled with an ash lens, soft ash, and burned rocks; and as lying between the fourth and fifth levels of fill (2D and 2E) at 4.3 feet BSD.

Observations from Notebooks

Judge identified Room 98 as extending from a masonry wall to a curved adobe wall in the west part of grid unit 140S/090E (Cat. No. 79.84.119).

At the bottom of the fourth level of fill (2D) a possible floor was found, but it disappeared 1 foot west of the west edge of a pit (F1) (Cat. No. 79.84.119).

Summary of Excavation by Level

Table 3.1 summarizes the 1973 excavation of Room 98 by level.

Comments by Judge

In clearing debris from the south road cut area, "2 or 3" adobe-walled rooms were identified and numbered (from west to east) 97, 98, and 99. These had been partly destroyed by the south road cut. Culturally sterile soil was found about 1 foot above the road, at the edge of the trash deposit. Room 98 was "possibly" a room (Cat. No. 93.16.10:10).

Room 97

1973 Excavation

Room 97 was west of and adjacent to room 98. James Judge led the 1973 excavation that identified this room. Four student notebooks (Cat. Nos. 79.84.109, .119, .120, and .122) describe work in the room from June 21 through July 4. Based on the available photographs, only part of Room 97 was excavated.

Data from Field Forms (Cat. No. 81.25.31)

The sub-datum for this room was at 140S/090E, without a stated vertical relationship to the datum.

Grid Level Records. A diagram shows the stratigraphy of four fill levels (2A–2C, 2D1, and 2D2) and the first floor (4A), with an adobe wall present in levels 2D1, 2D2, and 4A. The strata above the adobe wall continued east into Room 98. A form for the fourth level of fill (2D) indicates that 2D1 and 2D2 were arbitrary layers of the fourth level of fill level (2D). Presumably 2D1 and 2D2 are the same as the 2Dsub1 and 2Dsub2 shown in Table 3.3 (below).

The students suspected that the sediments below the first floor (4A) were sterile, based on stratigraphic tests in the adjoining rooms (98 and 99).

Observations from Notebooks

Judge defined Room 97 as the space between a curved wall and a vertical adobe slab in grid unit 140S/080E (Cat. No. 79.84.119). The room itself was in grid unit 140S/090E (Cat. No. 79.84.109).

The students dug a test area, and the room's east wall was found about 2 feet from grid location 140S/090E. The fourth level of fill (2D) was so large that they divided it into two sections, which they called "2Dsub1" and "2Dsub2" (Cat. Nos. 79.84.119 and .120).

One notebook (Cat. No. 79.84.120) indicates that flotation samples were taken from all levels that were not culturally sterile.

Summary of Excavation by Level

Table 3.3 summarizes the levels excavated in Room 97 in 1973.

Comments by Judge

In clearing debris from the south road cut area, "2 or 3" adobe walled rooms (numbered 97, 98, and 99 from west to east) were identified. These rooms had been partly destroyed by the road cut. Sterile deposits were found about 1 foot above the road, at the edge of the trash deposit. Judge indicated that Room 97 was definitely a room (Cat. No. 93.16.10:10).

Artifacts, Photographs, and Maps in the Collections

Table 3.4 summarizes the artifacts from Room 97 in the Maxwell Museum collections. No formal artifacts were found. The designation "S1" presumably refers to the first stratum.

The Maxwell Museum Archives include two photographs of Room 97 and two photographs of rooms 97, 98, and 99 (Table A.1). Figure 3.3 shows the excavated portion of Room 97. No detailed maps show Room 97.

Room 99

1973 Excavation

James Judge led the 1973 excavation that identified this room. Four student notebooks (Cat. Nos. 79.84.109, .119, .120, and .122) describe work in the room from June 21 through July 4.

Data from Field Forms (Cat. No. 81.25.31)

The sub-datum for this room was at 140S/100E, without a stated vertical relationship to the datum.

Grid Level Records. One form covering the six levels of fill (2A–2F) listed a feature, F1, <u>in</u> the fourth level of fill (2D). A second form covering the same six levels of fill (2A–2F) included a diagram of the stratigraphy and identified F1 as a pit <u>in</u> the fourth level of fill (2D).

Feature Forms. Feature 1 (F1), associated with the fourth level of fill (2D), was identified as a pit located at 4.65 feet BSD. The pit's center was at grid location 147S/109E, east of the adobe wall that the students thought was the room's east wall. The pit measured 2.25 feet across at the top, 1.6 feet across at the bottom, and was 2.0 feet deep. The pit was filled with sand, charcoal, bone, and a few sherds. The bottom of the pit (F1) reached sterile.

Another form for a pit designated Feature 1 (F1) associated that pit with the sixth level of fill (2F), with the bottom of the pit at 6.16 feet BSD. This pit was at 147S/105.6E and measured 1.7 feet at the north edge, 2.35 feet at the south edge, and 0.7 foot at its center. The pit was filled with sand, gravel, and a very small amount of ash and charcoal; it contained three sherds. A rodent hole in the center of the pit extended north. The students decided that the pit was not a cultural feature; instead, burrowing may have created the pit.

Observations from Notebooks

Judge defined the room as extending from a large adobe slab in the eastern part of grid unit 140S/100E to a masonry wall in the same grid unit (Cat. No. 79.84.119).

At the start of the season the students were unsure whether the east adobe wall was really a wall, so they defined a second provenience within the room. The area east of the dubious adobe wall was considered part of Room 99 and was dug using the same levels (Cat. No. 79.84.119).

The third and fourth levels of fill (2C and 2D) were not very different from each other, but were designated as different levels since they contained so much material (Cat. No. 79.84.119).

Typically, the students "floated" every fourth bucket of fill but for this room, they "floated" one bucket for each level and one for each feature (Cat. No. 79.84.119).

The students identified a pit, Feature 1 (F1), that extended from the fourth to the fifth level of fill (2D-2E). The pit contained a concentration of bones, ash, charcoal, and a few sherds, and was associated with Level 2D (Cat. No. 79.84.119).

Summary of Excavation by Level

Comments by Judge

In clearing debris from the south road cut area, "2 or 3" adobe walled rooms (numbered 97, 98, and 99 from west to east) were identified. The rooms had been partly destroyed by the south road cut. Sterile soil was found at about 1 foot above the road, at the edge of the trash deposit. Judge indicated that this location was not a room but retained its "Room 99" provenience. His interpretation of the levels is shown in Table 3.6 (Cat. No. 93.16.10:10).

Room 100

1973 Excavation

James Judge led the 1973 excavation that identified this room. Four student notebooks (Cat. Nos. 79.84.92, .103, .109, and .111) describe their work in the room from June 29 through July 19.

Data from Field Forms (Cat. No. 81.25.31)

Room Data Sheet. The sub-datum for this room was at 130S/090E, without a stated vertical relationship to the datum.

Room 100 was a habitation room. The fill included roof fall under silt, which was under loose material and backdirt. A subfloor test was placed in the room but the lowest level of cultural fill was not reached.

Four features (F1–F4) were associated with the first floor (4A).

Plaster was found on the north, east and west walls (Table 3.8).

Depths of the four corners of the room were recorded as 2.9 feet BSD (northeast and northwest corners) and 0.3 foot BSD (in the bin in the southwest corner). The fill in the southeast corner was pedestaled.

Grid Level Records. The features associated with the first floor (4A) included a storage bin (F1) in the northeast corner of the room (just north of a post hole), a hearth (F2) against the middle of the east wall just east of another hearth (F4), and a possible storage bin (F3) along the west wall (in the southwest quadrant of the room).

A possible slab-lined floor was identified about 1 inch below the first floor (4A).

Feature Forms. The first floor (4A) had been re-plastered and was underlain by another floor.

F1 was a storage bin located at 1.6 feet BSD, associated with the first floor (4A). The bin measured 1.4 by 2 feet and extended 2.2 feet deep. The bin fill was mostly adobe chunks, with soft fill near its bottom.

A hearth (F2) associated with the first floor (4A) had its bottom at 3.3 feet BSD. It was found against the room's east wall. F2 measured 2 by 2 feet and extended 0.5 foot from the top of the rim to the bottom of the hearth. The fill was mostly ash, with adobe on top. The adobe rim rose about 2 inches above the floor (4A). The base of the hearth was made of adobe and stone slabs. An adobe "hump" was associated with a rock in front of the hearth; the students thought that the hump may have supported a flat rock as a sort of trivet.

A possible bin (F3) associated with the first floor (4A) was found against the room's adobe west wall, just south of a post hole, with floor plaster sloping up to it. The bin was located at 3 to 3.2 feet BSD. It measured 2.5 by 1.6 feet. The very crumbly fill consisted of adobe slump and roof fall.

A plastered-over hearth (F4), located at 3.5 feet BSD, measured 1.7 by 1.8 feet and was 0.5 foot deep "to its shelf." The hearth fill consisted of adobe mixed with dirt, pebbles, and some ash "on the shelf." F4 was located next to the other hearth (F2).

Observations from Notebooks

The students began by identifying the first level of fill (2A) and the first floor (4A). A few items from the first floor (4A) were combined with items from the first level of fill (2A) (Cat. No. 79.84.111), so the exact proveniences of items from those levels are questionable. The descriptive details for these two proveniences may be similarly mixed.

F1 was a storage bin in the northeast corner of the room (Cat. Nos. 79.84.103 and .109). A hearth with an adobe rim (F2) extended about 4 feet below the top of floor 4A (Cat. No. 79.84.109). An eroded bin (F3) was found 1 to 1.5 feet north of the room's south wall; this bin had an adobe rim extending about 1.5 feet into the room (Cat. No. 79.84.109). The plastered-over hearth (F4) had sides consisting of adobe and upright slabs (Cat. No. 79.84.111). F4 was just west of hearth F2 (Cat. No. 79.84.109).

Subfloor tests were conducted in the area with F3 and F4 (Cat. No. 79.84.111).

The remaining masonry south wall was about 3 inches high. The west wall was adobe, and the floor plaster curved up onto the wall. The whitewashed and partly plastered east wall was similar to the west wall. The north wall was adobe with stone; it was whitewashed and plastered three-quarters of the way up the wall (Cat. Nos. 79.84.109 and .111).

The north-south walls abutted the east-west walls. The first level of fill (2A) was very thick because the room was located on a slope (Cat. No. 79.84.109).

The floor (4A) was re-plastered (Cat. No. 79.84.109).

Summary of Excavation by Level

Comments by Judge

The students identified the room when they started removing a masonry wall in grid unit 140S/090E, to begin digging a trench to the north. A good floor was found associated with a masonry wall. The students dug the first level of fill (2A) and the first floor (4A) in a 5 by 5 foot unit in grid unit 130S/090E (Cat. No. 93.16.10:12).

A subfloor test exposed a slab-lined floor below the first floor (4A) and then stratified trash. Judge thought that Room 100 was a habitation room used for food processing. The crew abandoned the idea of trenching below the room in 1973 as there would be problems stabilizing it (Cat. No. 93.16.10:15).

1974 Summary of Judge Excavation

Data from Field Forms (Cat. No. 78.84.278A)

Room 100 was in grid unit 130S/090E. It was used for food processing <u>including</u> cooking. Excavation reached 2.9 feet BSD and included the unit surface (1A), two levels of fill (2A, 2B), one roof fall level (3A), and the first floor (4A). Subfloor tests were not conducted.

The adobe first floor (4A) was plastered and burned, with four features (two hearths and two bins), and measured 12.2 by 10.4 by 2.9 feet. The walls were adobe and masonry.

Room 100 appears on maps created from 1973 through 1976. All of the maps provide plan views only (Table A.2). None shows the room plan in detail.

Chapter 4

OTHER BLOCK 5 ROOMS

Rooms 3, 9, 10, 25, 26, and 127, in Room Block 5, were excavated beginning in 1971. Work in Room 3 ended in 1971. Excavation of Room 9 continued in 1972. The work in Rooms 10, 25, and 26 (quickly redefined as two rooms, 26A and 26B) continued in 1972 and 1973. Room 127 was excavated in 1976. Figure 1.1 shows the locations of the rooms within the room block. Figure 2.1 also shows these rooms, with the exception of Room 127.

Room 10

1971 Excavation




Figure 4.1. Plan and profile of Room 10. Source: Cat. No. 2006.1.13.

James Judge led the 1971 excavation that identified this room, shown in Figure 4.1. Seven student notebooks (Cat. Nos. 79.84.47, .48, .51, .53, .62, .63, and .278) describe work in the room from June 29 through July 22.

Data from Field Forms (Cat. Nos. 79.84.3 and 2005.25.15669)

Room Data Sheet. The sub-datum for this storage room was at 100S/080E, at 11.78 feet BD.

Room 10 had two burned adobe floors, and a cist was associated with each floor (Table 4.2, below). Room fill consisted of charcoal, adobe chunks, dispersed sherds, and bone fragments. Neither the lowest floor nor sterile was reached.

The west halves of the north and south walls were burned, as were the south halves of the east and west walls. The east, south, and west walls were partly plastered and the north wall was completely plastered. Either viga remnants or sockets (it is not clear which) were found in the south wall and at two levels in the east wall. In addition to the four walls, the room had a short wing wall_(Table 4.1). Like the east wall, the short partition also had vigas/sockets on two levels.

Depths of the four corners of the room were recorded as 0.38 foot BSD (northeast), 0.45 foot BSD (southeast), 1.35 foot BSD (southwest), and 0.9 foot BSD (northwest).

Feature Forms. Test Trench 1, in the northeast corner of the room, was in a feature (F1) associated with the first floor (4A) and the room walls. The fill was sandy clay with charcoal and adobe chunks. Test Trench 1 (F1) was located 4.6 feet below the surface, and 2 feet south of and 3.3 feet west of the room's northeast corner.

Observations from Notebooks

The students found evidence of burning in the first layer of fill (2A): the room's plastered walls were described as "reddish," possibly burned in spots (Cat. Nos. 79.84.53 and .278). Burned timbers were found in the fill <u>above</u> the first floor (4A) (Cat. No. 79.84.62), along with burned artifacts including <u>sherds from a restorable vessel</u> or <u>vessels</u>, a mano, and a metate (Cat. No. 79.84.278).

The students dug a test in the northeast corner of the room, in what appeared to be a pit or cist (Cat. No. 79.84.278). A second test pit was placed in the southwest corner of the room (Cat. No. 79.84.53).

An adobe wing wall extended 3.5 feet out from the masonry south wall. It continued downward through the first and second levels of fill below the first floor (5C, 5D) (Cat. Nos. 79.84.53 and .278).

Viga sockets were found in the east and west walls about 2 inches below a floor, with a second set of viga sockets about 3 feet down from the first hole (about 7.5 feet below the surface level) (Cat. No. 79.84.53).

A dog burial was located in a hole in the north wall (Cat. No. 79.84.48).

The interior corners of the room were recorded at grid positions 105.3S/076.75E (southeast), 098.55S/080E (northeast), 101.5S/069.25E (southwest), and 095.5S/072.35E (northwest) (Cat. No. 79.84.278).

1972 Excavation

James Judge led the excavation of Room 10 in 1972. Five student notebooks (Cat. Nos. 79.84.69, .70, .74, .79, and .91A) describe work in the room from June 13 through July 18.

Data from Field Forms

Grid Level Records (Cat. No. 79.84.3). The 1972 excavation began at the sixth level of fill below the first floor (5F). The first level of roof fall (3A) reported was found that year.

The 1972 records discuss only one floor (4A). A test trench excavated in 1971 penetrated a second floor (4B), so I assume that the 1971 field forms were not available to the 1972 excavators. Remains found under the east wall were labeled "East Sub Wall Fill."

The east wall ended at 4.3 feet BSD.

The 1971 test trench was in the southeast part of the room and extended from the middle of the room to the east wall.

Observations from Notebooks

One student (Cat. No. 79.84.70) provided more details about the second floor (4B). The student indicated that the first floor (4A) was excavated in 1971. The second floor (4B) was excavated in 1972 and extended under a "partition," also described as a "later west wall." This was the adobe wing wall. described in 1971 as extending from the masonry south wall (Table 4.2). The student also described the second floor (4B) as extending through the east side fill. The east wall was associated only with the first floor (4A). No east wall was found for the second floor (4B). A test trench was dug after the removal of the second floor (4B).

Excavation in 1972 confirmed the presence of a wing wall extending about 3 feet out from the south wall, and the existence of viga sockets in the east and partition walls (Cat. No. 79.84.69). Irregular stone masonry was found on top of adobe in the south wall, in the room's southwest corner. The room's north wall consisted of two walls, one built on top of (but offset from) the other (Cat. No. 79.84.69).

A third floor (4C) was exposed (Cat. No. 79.84.79).

A basin (remains of a subfloor pit) was found in the northeast corner of the room. The basin was burned throughout the floor and adobe levels (Cat. No. 79.84.79).

At the end of the season, the excavation was covered with plastic, which was weighted down with rocks and covered with dirt. Red stakes were placed at the four corners of the room to prevent people from falling through the rotting lumber (Cat. No. 79.84.91A).

Summary of Excavation by Level

Table 4.3 summarizes the levels excavated in Room 10 in 1972.

1973 Excavation

James Judge led the excavation of Room 10 in 1973. Two student notebooks (Cat. Nos. 79.84.90 and .101) describe work in the room on June 15.

Observations from Notebook

A student notebook (Cat. No. 79.84.90) includes a sketch in which Room 10 spans four grid units (090 and 100S/060 and 070E). The sub-datum is listed as being at 100S/080E.

Data from Field Forms (Cat. No. 79.84.278A)

Room 10 was in grid unit 090S/070E. When the first and second floors were in use, room function was "possibly habitation." When the third floor was in use, room function was "possibly food processing." Judge's excavations included the first and second levels of fill (2A, 2B), the first level of roof fall (3A), three floors (4A–4C), and seven levels of fill below the first floor (5A–5G), to a depth of 11.2 feet BSD.

A note indicates that most of the data sheets for the room were lost. Based on personal memory, the preparer of the form suggested that the second level of fill (2B) ended at a floor remnant from a second story room and that the first story room was above offset adobe walls. The form also includes a discussion of the fact that in both 1971 and 1972, a floor was reported at 11.2 feet BSD.

Table 4.4 summarizes the three floors. Each wall was adobe and was associated with a burned plastered cist.

Room 10 appears on maps created in 1971 and from 1973 through 1976. All of the maps provide plan views. One 1971 map provides a profile (Table A.2).

Room 9

1971 Excavation




Figure 4.3. Plan and profile of Room 9. Source: Cat. No. 2006.1.13.

James Judge led the 1971 excavation of Room 9, which is shown in Figure 4.3. Six student notebooks (Cat. Nos. 79.84.35, .46, .47, .49, .51, and .63) describe work in the room from June 25 through July 22.

Data from Field Forms (Cat. No. 79.84.3)

Room Data Sheet. The sub-datum for this room was at 110S/100E, at 11.68 feet BD.

Room 9 had two east walls and two south walls (Table 4.6). The east wall measurements in Table 4.6 are for the "old adobe east wall." About 0.4 foot east of that wall was a rock and adobe east wall. Only a small portion of the second adobe south wall remained.

Room 9 was a habitation room with three adobe floors, each with an associated fire pit (Table 4.6). Room fill consisted of ash, hard adobe chunks, and charcoal. It is not clear that the lowest floor was reached. A test pit was taken down about 2 feet but sterile was not reached.

Depths of the room corners (below the level of the third floor?) were recorded as 2.25 feet BSD (northeast), 2.18 feet BSD (southeast), 0.56 foot BSD (southwest), and 0.65 foot BSD (northwest).

Grid Level Records. There is some confusion in the BD versus BSD measurements for the first and third floors (4A, 4C), and in the relationship of the first level of roof fall (3A) to the second and third floors (4B, 4C).

Feature and Test Forms. A fire pit (F1) was identified in the first level of fill below the first floor (5A). It measured 0.3 foot long by 0.8 foot wide; the fill was ash, adobe "ridge," and dirt. F1 was associated with the first floor (4A) and with an ash lens.

An opening (F2) was found in the west wall, at 0.4–2.5 feet BSD. This opening measured 1 foot wide by 1.2 feet high. The top of the wall was 1.7 feet from the bottom of the opening. F2 was filled with adobe and associated with a second filled hole (which was square) in the same wall.

The bottom of a fire pit (F3) was located at 2.8 feet BSD. It was identified in the first level of fill below floor 4A (5A) and associated with the second floor (4B). The fire pit measured 1.5 by 1.4 feet by 0.4 foot deep and contained ash.

A fire pit (F4) was found at 5.4 feet BSD and measured 1.7 by 1.5 feet by 0.6 foot deep. It contained ash fill topped with packed adobe. F4 was associated with the third floor (4C), which was also made of packed adobe. The sides of this fire pit were lined with slabs that did not protrude above the third floor (4C).

Test 2 (T2) was located at 6.4 feet BSD. A test trench was taken down 2 feet below floor level in the northwest corner of the room in search of an additional floor (which was not found). The west wall appeared to end at floor level. Sterile was not reached.

Observations from Notebooks

The west wall included adobe that looked like a sealed opening (identified as F2) into Room 6, at the same level as fire pit F1. The adobe was red instead of gray like the rest of the wall (Cat. Nos. 79.84.35, .47, .51). The students found a small area of floor at the same level as the sealed opening (F2) in the west wall (Cat. Nos. 79.84.46 and .49). A large piece of burned wood at the same approximate depth may have been from roof fall (Cat. No. 79.84.46).

Fire pit F4 was lined with upright slabs and associated with the hard third floor (4C). The tops of the slabs showed at floor level. The first 0.15 to 0.2 foot of F4 was plastered with adobe. F4 appeared to be plastered over, with abundant ash under the adobe (Cat. No. 79.84.35).

The top of the south wall was masonry and the bottom was adobe. The west end of the bottom (adobe) portion of the wall abutted the west wall. The top (masonry) part of the wall wrapped continuously around the southwest corner (Cat. No. 79.84.35). The upper part of the south wall was offset from the lower part of the wall, to the degree found in a double wall. The east wall also was a double wall, again with stone above and offset from an adobe wall (Cat. No. 79.84.46). The two adobe wall segments seemed to have been built together to form the corner. The masonry lower south wall abutted the lower masonry west wall (Cat. No. 79.84.46).

Summary of Excavation by Level

Table 4.7 summarizes the 1971 excavation of Room 9 by level.

1972 Excavation

James Judge led the continued excavation of Room 9 in 1972. Four student notebooks (Cat. Nos. 79.84.72, .73, .79, and .83) describe work in the room on June 14.

Data from Field Forms (Cat. No. 79.84.3)

Grid Level Records. Test 2A (T2A) was located at 5.65 to 6.18 feet BSD and measured 2.7 by 3.2 feet. This test was dug in search of the culturally sterile substrate, which was not found.

Observations from Notebooks

Since sterile was not reached in 1971, the students continued excavating Test 2 (T2) and renamed it Test 2A (T2A). They dug T2A to a depth of 6 feet BSD and then abandoned work in the room without reaching sterile (Cat. Nos. 79.84.72 and .83).

1974 Summary of Judge Excavations

Data from Field Form (Cat. No. 79.84.278A)

This form places Room 9, a habitation room, in grid unit 100S/100E. It confirms excavation of the first level of fill (2A), the first level of roof fall (3A), three floors (4A–4C), and two levels of fill below the first floor (5A, 5B). The wall and floor information (Table 4.8) is inconsistent with the information on the 1971 room data sheet (Table 4.7).

Room 9 is described as two rooms: an upper masonry room offset from a lower adobe room. The doorway in the west wall, leading into Room 6, was described as possibly associated with the second floor (4B). The first and second floors (4A, 4B) were described as remnants surrounding fire pits but otherwise "floating in fill." The third floor (4C) included a lined fire pit (F3). Fire pit F2 was directly below fire pit F1. This may be a misunderstanding based on one student notebook (Cat. No. 79.84.51) that refers to F2 as a fire pit. All other 1971 documentation of F2 describes it as the doorway and indicates that fire pit F3 was found directly below fire pit F1 (see Table 4.6).

The first floor (4A) was associated with the masonry-walled room; the third floor (4C) was associated with the adobe-walled room. On the form, the second floor (4B) was not associated with either room. The west wall, of mixed materials, was used for both rooms.




Figure 4.4. Room 9, fire pit (F3) on second floor (4B). Source: Cat. No. 80.24.583A.

Room 9 appears on maps created in 1971 and from 1973 through 1976. All of the maps provide plan views. One 1971 map (Cat. No. 2006.1.13) also provides a profile (Table A.2).

Room 3

1971 Excavation




Figure 4.5. Plan of Room 3. Source: Cat. No. 2006.1.3.

James Judge led the 1971 excavation of Room 3, which is shown in Figure 4.5. The excavation stopped before the floor was identified (Cat. No. 79.84.278A). Eight student notebooks (Cat. Nos. 79.84.35, .42, .43, .46, .47, .51, .62, and .63) describe work in the room from June 16 through June 25.

Data from Field Forms (Cat. No. 79.84.2)

A grid level record for the second surface level (1B) placed that level at 11.93 feet BD/0.25 foot BSD. An associated diagram shows a profile of the room and places it in grid unit 120S/100E.

Observations from Notebooks

The room was first identified in grid unit 120S/090E after a stone and mud mortar wall was found in grid 120S/100E (Cat. Nos. 79.84.47 and .51). The students began looking for a floor by following the wall down in 0.3 foot increments. In the second such increment, under a pale yellow sandy layer, the ash lenses became larger and were associated with burned adobe (Cat. No. 79.84.46).

A test pit was dug in the southwest corner of the room (Cat. Nos. 79.84.62, 43). Although one notebook records the test pit as being in the southeast corner of the room, sketches in both notebooks place it in the southwest corner.

Three walls were identified; one was adobe (Cat. Nos. 79.84.46 and .63).

Summary of Excavation by Level

Level 2A was 0.6 foot thick. The fill included large clumps of adobe about 1 foot from the north wall. Rodent burrows were present throughout the room (Cat. No. 79.84.43).

Since no south wall was found, the excavation was stopped. The students thought that Room 3 might not be a room (Cat. No. 79.84.35).

1974 Summary of Judge Excavation

Data from Field Form (Cat. No. 79.84.278A)

Room 3 was in grid unit 120S/100E. Two surface levels (1A, 1B) and the first level of fill (2A) were dug to 6.3 feet BSD. A masonry first floor (4A) was found, but a south wall was not. Fill was wall fall and wash. Part of Room 9 was offset over the north wall of Room 3.

Artifacts, Photographs, and Maps in the Collections

Table 4.10 summarizes the recovered materials in the Maxwell Museum collections. All of the artifacts with reported excavation dates were found in 1971. At least one specimen of burned adobe was attributed to an unidentified feature (F2).

Room 25

1972 Excavation




Figure 4.7. Plan of Rooms 25, 26A, and 26B and profile of Rooms 25 and 26B. Source: Cat. No. 2005.25.15159.

James Judge led the 1972 excavation that identified Room 25, which is shown in Figure 4.7. Seven student notebooks (Cat. Nos. 79.84.65, .70, .72–.75, and .79) describe work in the room from June 26 through July 19.

Data from Field Forms (Cat. No. 79.84.9)

Room Data Sheet. The sub-datum for this room was at 120S/120E, at 15.24 feet BD.

Room 25 was a utility room filled with adobe wash, adobe chunks, and rock fall. The first floor (4A) was excavated in 1972; this may not have been the lowest floor.

A sealed doorway was found in the south wall. Other wall details are provided in Table 4.11.

Grid Level Records. A diagram for the tenth level of fill (2J) shows an unidentified feature (F1) against the middle of the north wall, and three viga sockets in the room's southeast quadrant. F1 was later identified as a mealing bin that contained two metates, three manos, and a slab.

A diagram for the first level of roof fall (3A) indicates that at the time that level was excavated, the west half of the room was not excavated below the eighth level of fill (2H).

The students began excavating the west half of the room at the tenth level of fill (2J). A diagram shows that 2J was slightly higher than the first floor (4A).

The first floor (4A) incorporated worked stone slabs near the center of the north wall and fitted rock slabs in the northeast corner of the room. An undated diagram suggests that the "fitted rock slabs" are F2.

Feature Forms. The mealing bin (F1) was made of worked stone slabs and was found at 5.0 feet BSD, at grid location 118.5S/124.6E. The mealing bin measured 2.4 by 2.05 feet by 1.3 feet deep. Its fill included adobe wash, stone slabs, and general room fill.

The fitted stone slabs (F2) were found at 5.5 feet BSD, at grid location 119.8S/129.3E. The group of slabs measured 1.3 by 1.4 feet across by 0.1 foot deep. The slabs were flush with the surface of the first floor (4A).

Observations from Notebooks

The room was identified in grid units 120S/120E and 120S/130E (Cat. Nos. 79.84.70 and .79).

By July 13 the students decided to excavate the east half of the room first, then the west half in natural levels (Cat. No. 79.84.79).

After clearing the first floor, the students backfilled the room (Cat. No. 79.84.65).

1973 Excavation

James Judge led the continuing excavation of this room in 1973. Three student notebooks (Cat. Nos. 79.84.97, .114, and .115) describe work in the room on June 5 and June 19. No field forms were found for the 1973 work.

Observations from Notebooks

The room's east wall had been completely lost to erosion since the 1972 season (Cat. No. 79.84.97).

One notebook (Cat. No. 79.84.97) describes an attempt to reach sterile deposits below the first floor (4A) excavated in 1972. The students excavated a 3 by 3 foot test pit in the southeast corner of the backfilled room to find the first floor (4A), then continued down about 3 inches through a red layer underlain by a brown layer. About 5 inches below the surface of the first floor (4A), the students identified a "possible surface" or second floor, but mostly shoveled through it. They identified a second floor (4B) 6 inches below the surface of the first floor (4A), but did not dig below that second floor.

A second notebook (Cat. No. 79.84.115) indicates that the second floor (4B) was found in the southeast corner of the room. This second floor was black and hard, with red fill under it, and was about 6 inches below the first floor.

According to a third notebook (Cat. No. 79.84.114), the students identified up to three floors. A profile diagram in the notebook shows adobe wash with packed dirt above it and an adobe wall below it. Below the adobe wall was a 2 inch thick layer marking the first floor (4A). This layer was moist dark brown clay or adobe. Below the first floor (4A) was a slab floor. Below the slab floor was brown-black fill, and at the bottom of the unit was an even lower floor.

1974 Summary of Judge Excavations

Data from Field Form (Cat. No. 79.84.278A)

Room 25 was a food processing room in grid unit 110S/120E. The excavation included 10 levels of fill (2A–2J), a first floor (4A) at 5.5 feet BSD, and a subfloor test in the southeast quadrant of the room, reaching a depth of 6.0 feet BSD. The adobe and slab first floor (4A) measured 10.8 by 7.7 feet; it lay at a depth of 5.5 feet BSD and included a mealing bin and a cist. The walls are reported as adobe, with three doors and possible vigas.

Artifacts, Photographs, and Maps in the Collections

Table 4.13 summarizes the artifacts from Room 25 in the Maxwell Museum collections. Since artifacts were recorded as coming from a second floor (4B) and a test pit (T1) associated with that floor, I assume that even without field forms for the second floor, the floor actually existed.

The Maxwell Museum Archives include 10 photographs of Room 25 (Table A.1). Figure 4.8 shows the room's first floor (4A), with the collapsed mealing bin visible against the north wall.

Room 25 appears on maps created from 1972 through 1976. All of the maps provide plan views; one 1972 map (Cat. No. 2005.25.15159) also provides a profile (Table A.2).

Room 26 (26A and 26B)

1972 Excavation

James Judge led the 1972 excavation of what was first designated Room 26. After several days of work, the unit was later redefined as two rooms, 26A and 26B (Figure 4.7). Eight student notebooks (Cat. Nos. 79.84.69, .72, .73, .75, .79, .83, .86, and .91A) describe work in the rooms from June 26 through July 19.

Data from Field Forms (Cat. No. 79.84.10)

Room Data Sheet—Room 26A. The sub-datum for this room was at 120S/130E, at 16.87 feet BD.

Room 26A featured a cist containing a rock stained with ground hematite, and a lightning stone was found on the floor near the cist. As a consequence, the room was thought to be ceremonial, possibly a kiva, The room's west adobe wall may have been built first, with the three masonry walls added later. Additional wall details are provided in Table 4.14. The room fill was coarse sand at the top and concentrated adobe wash below. The first floor (4A) was excavated in 1972, but no subfloor test was made that year.

Depths of the four corners of Room 26A were recorded as 3.3 feet BSD (northeast), 3.25 feet BSD (southeast), 2.85 feet BSD (southwest), and 3.0 feet BSD (northwest).

Grid Level Records. The students found a cist and a possible cist cover and referred to both of them as Feature 1 (F1).

The possible cist cover (F1, in part) was associated with Room 26A's first floor (4A). It was found at 3.2 feet BSD, just north of a charcoal deposit mixed with maize cobs and kernels.

Feature Forms. A diagram shows the possible cist cover (F1, in part) as a series of tabular fragments of a circular to oval slab (located at 3.4 feet BSD; associated with the first floor [4A] at 3.0 feet BSD). A second diagram shows a hematite deposit, found in loose fill with adobe, located at 4.0 feet BSD.

The cist (F1, in part) was found at 3.2 feet BSD at grid location 127.5S/135E. The cist measured 1.7 feet in diameter and 0.8 foot deep. A hematite stain was present on one of the rocks used to define the feature.

Room Data Sheet—Room 26B. The sub-datum for Room 26B was at120S/130E, at 16.87 feet BD (the same as for Room 26A).

As of 1972, the function of Room 26B was not determined. The room fill was sheet wash, adobe chunks, and masonry. The west wall had some evidence of plaster. Additional wall details are provided in Table 4.15. The first floor (4A) was excavated but the students did not know whether additional floors were present.

Depths of the four corners of Room 26B were recorded as 3.1 feet BSD (northeast), 3.75 feet BSD (southeast), 3.2 feet BSD (southwest), and 2.7 feet BSD (northwest).

Grid Level Records. A diagram shows that Room 26B's adobe and masonry south wall served as Room 26A's north wall.

Observations from Notebooks

Room 26 (as the unit was then defined) was a large room in grid unit 110S/130E; it extended east into grid units 110S/140E and 120S/130E (Cat. No. 79.84.69).

By June 29, during excavation of the third level of fill (2C), the students began referring to north and south portions of the room (Cat. No. 79.84.83). By July 5 they started referring to the north part of the room as 26B and the south part of the room as 26A (Cat. No. 79.84.72). A "definite separation" was noted between the north and south sections of the room, with more "goodies" being found in the south portion (Cat. No. 79.84.72). By July 12 the students were convinced that two rooms were present, with the south room used for storage (Cat. No. 79.84.79). The north room was identified as 26B and the south room as 26A (Cat. No. 79.84.83).

Once the students defined the two rooms, the first level excavated in Room 26A was the first floor (4A), while the first level excavated in Room 26B was the third level of fill (2C) (Cat. No. 79.84.79).

Feature 1 (F1) in Room 26A was a cist under the slab floor. Beneath a covering slab was a layer of fitted stones plastered with adobe. Under the stones was soft fill with charcoal, ash, and bones. The cist extended down about 1 foot, to hard adobe, and was 2 feet in diameter. One of the stones making up the cist lining was stained with hematite (Cat. No. 79.84.69).

A different notebook (Cat. No. 79.84.79) indicates that the pit in Room 26A contained a small amount of maize and a rock covered with red ocher. The students thought the pit was ceremonial since they found a lightning stone and a second rock covered with red ocher nearby.

A notebook diagram (Cat. No. 79.84.83) shows a wall abutment suggesting that Room 26B was built before room 26A (see also Figure 4.7). There was a noticeable break in the east wall of Room 26 as originally defined, involving two patterns of masonry. In the east wall of Room 26A, the masonry was not as carefully fitted as in the east wall of Room 26B, and adobe mortar was used more generously. The southwest corner of Room 26B was curved and abutted Room 25, where the masonry ended. Rooms 26B and 26A both had west walls that were all adobe.

The wall between Rooms 26B and 26A continued down through the second floor identified in Room 26A (Cat. No. 79.84.69).

By mid-July, what the students had thought was a kiva because of its size was now seen as two "normal" sized rooms (Cat. No. 79.84.69).

Summary of Excavation by Level

The notebooks and forms variously describe the 1972 work in this part of the site as being in Room 26, Room 26A, or Room 26B (Tables 4.16–4.18).

1973 Excavation

James Judge led the continuing excavation of Rooms 26A and 26B in 1973. Two student notebooks (Cat. Nos. 79.84.97 and .115) describe work in the room on June 5 and June 19.

Observations from Notebooks

The cist in Room 26A was in the room's southeast corner. A test pit was dug in the southwest corner of the room to search for sterile. The students found an adobe floor (4A), and below it a rock slab second floor (4B) (Cat. No. 79.84.97). These finds are consistent with the ones made in 1972 (Table 4.17).

A different floor, this one of adobe, was found about 5.5 inches below the original adobe surface. This second floor was moist and brown, with red streaks (Cat. Nos. 79.84.97 and .115).

1974 Summary of Judge Excavations

Data from Field Form (Cat. No. 79.84.278A)

On this form, Rooms 26A and 26B were considered to be a single large room, Room 26, a kiva in grid unit 110S/130E. Excavated levels include the first surface (1A) level, four levels of fill (2A–2D), and the first floor (4A), reaching a depth of 3.0 feet BSD.

The first floor (4A) measured 18.8 by 10.0 feet, was made of slabs plastered with adobe, and included a cist and a "burner." Walls were adobe and masonry.

Based on a subfloor test pit, the sterile substrate had not been reached. Recovery of several bushels of maize from above and within roof fall suggested that maize was being stored on the roof when the room burned.

An east-west rock wall divided the room at the floor level.

The form suggests that the room may have been two rooms that were combined to create a kiva.

Artifacts, Photographs, and Maps in the Collections

Tables 4.19, 4.20, and 4.21 summarize the artifacts found in Rooms 26, 26A, and 26B according to the proveniences assigned by the excavation crews. In general, Table 4.19 represents materials collected before Rooms 26A and 26B were distinguished. In some cases, items may have been mislabeled (e.g., when they were assigned to Level 4A-F1 in Room 26).

No maps show Room 26 (that is, before the work area was divided into two rooms). Rooms 26A and 26B appear on maps created from 1972 through 1976. All of those maps provide plan views; one 1972 map (Cat. No. 2005.25.15159) provides a profile of Room 26B (Table A.2).

Room 127

1976 Excavation




Figure 4.10. Plan and profile of Room 127. Source: Cat. No. 2005.25.15174.

Linda Cordell led the 1976 excavation of Room 127, shown in Figure 4.10. Two student notebooks (Cat. Nos. 79.84.215 and .217) describe work in the room from June 23 through July 21.

Data from Field Forms (Cat. No. 79.84.34)

Room Data Sheet. Room 127 was a two story habitation structure. The fill was sandy and loamy and included adobe slump, caliche, charcoal, and ash. A subfloor test extended down to sterile.

The walls were plastered. A doorway was present in the south wall. The south and west walls showed evidence of burning. Additional wall details are provided in Table 4.22.



Depths of the four corners of the third floor (4C) were recorded as 3 feet BSD (northeast and southeast), 2.8 feet BSD (southwest), and 3.8 feet BSD (northwest).

Grid Level Records. A diagram for the first level of roof fall (3A) indicates adobe plaster on the north wall and an adobe east wall. The north, west, and south walls were eroded adobe with possible plaster surfaces. A diagram shows the north wall with red plaster.

Two forms were completed for the floor identified as "YA." According to a form for a different floor, 4C in Test Pit 1 (T1), the floor "looks and feels like sterile." However, the student notebooks indicate that excavation included the first level of fill below 4C (7A). This level "appeared sterile" but two sherds were found.

Feature Forms. Two forms may or may not describe the same feature. The first form identifies F1 as a group of rocks in the center of Room 127, at 17.28 feet BD. Two ceramic artifacts are marked but not identified. The second form identifies F1 as a hearth found at 16.88 feet BD (2.25 feet BSD), with its center at grid location 092.4S/120E. The hearth measured 3 feet north-south by 2 feet east-west, and extended from 16.88 to 17.28 feet BD. It was filled with ash and charcoal, was found on a floor, and contained a ceramic figurine (identified as an Earth Mother) and a mano.

A different form identifies F1 as a fire pit that extended into the north wall of the room at grid location 092.4S/118.7E. The fire pit was located at 17.68 to 18.13 feet BD, 3.3 feet below the surface; it measured 1.7 feet by 1.25 feet and 0.25 foot deep. This fire pit seems to be the fire pit (F1) found on the first floor (4A) referred to in Table 4.23 (below). The fire pit (F1) is further described as semicircular, with upright small stones and a chunk of hard burned adobe in the bottom.

F2, an ash pit associated with the first floor (4A), was located at 17.63 to 18.53 feet BD (3.9 feet BSD) at grid location 094.6S/119E. It was circular in plan, was lined with about 0.1 foot of red adobe, and measured 1.9 feet across by 0.9 foot deep. The ash pit was south of the fire pit (F1) and was filled with ash, charcoal, and adobe.

Observations from Notebooks

Room 127 was identified in grid unit 090S/120E, in Trench D, which at the start of the excavation of Room 127 was identified as extending from 060 to 100S along 121E. Trench D cut through the east third of the room (Cat. No. 79.84.215). By July 6, Trench D had been further excavated, now extending from 042 to 090S and 121 to 124E (Cat. No. 79.84.217).

The notebooks (and also the field forms) betray confusion about the depths of various levels, including a failure to state whether levels were in Room 127 or in Trench D. At the least, these discrepancies extend to Levels 2B (the second level of fill) and 3A (the first level of roof fall).

The sub-datum for the room was at 100S/120E, at 14.63 feet BD (Cat. No. 79.84.215).

In talking to the students, Cordell suggested that finding roof fall underlain by adobe slump indicated the room may have been two stories, with the adobe slump being what was left of the second story floor (Cat. No. 79.84.215).

The south wall was smooth; it was coated with caliche and gray plaster (Cat. No. 79.84.217). The west wall was also coated with gray plaster (Cat. No. 79.84.217).

A smooth surface was found in the southeast corner of the room below the second level of fill (2B). Cordell agreed that this surface probably was the floor from the second story. The students referred to this floor as "the first second floor" or "the second story floor" and coded it as "YA" (Cat. Nos. 79.84.215 and .217).

A hearth (F1) associated with the second story floor (YA) contained a mano and what Cordell described as an "Earth Mother fertility fetish" (Cat. Nos. 79.84.215 and .217).

A fire pit (F1) containing a slab of hard baked adobe was found on the first floor (4A), against and extending into the north wall of the room. Rock slabs were found in the north wall at the back of the fire pit. The fire pit fill was described as "slumpish" on top, with burned wood directly under slump and a layer of ash just above the adobe slab floor (Cat. No. 79.84.215). The students first thought that the floor (4A) was a remodeling of a lower level floor since it was almost entirely intact, with the fire pit (F1) still in place. The ash pit (F2) in the center of the room, filled with ash and soil, was almost perfectly circular, was bowl-shaped, and was lined with about 1 cm of red clay or adobe (Cat. No. 79.84.217).

The fill above the first floor (4A) was soft, trashy brown dirt with charcoal and clay (Cat. No. 79.84.215).

During excavation of the first level of fill below the first floor (5A), the students identified a sealed doorway in the south wall (Cat. Nos. 79.84.215 and .217). They followed the south wall down through several levels of fill below the first floor (5A–5E) (Cat. No. 79.84.215).

During the last two days of the field season, further excavation of Room 127 was limited to a test pit (T1) in the southwest corner of the room, at grid location 096–099S/014.5–017.7E (Cat. No. 79.84.217). Small pieces of wood under the west wall were identified as wall support posts. Excavations of the second and third levels of fill below 4A (5B, 5C) in the test pit (T1) indicated that at least one such support post extended at least that deep, finally becoming crumbly in the fourth level of fill (5D). At the third floor (4C) in the test pit (T1), the south wall lost its plaster surface and became eroded and crumbly.

Published Comments

Room 127 had two stories. The fallen second story floor was broken up but the remains of a fire pit were found under roofing material (all of this above an intact floor with a fire pit and an ash pit) (Cordell 1977b).

The five tree-ring dates from Room 127 ranged from 1287rB to 1370VV. Three were from roof fall (3A); they included two cutting dates (1287r and 1311) and one non-cutting date (1369) suggesting the reuse of roof beams. The fourth date was from the first level of fill (2A) and the fifth was from the second story floor (YA) (Cordell 1977:186, 200, Lumpkin in Cordell 1977b:246).

Chapter 5

ROOM BLOCK 6, ROOMS 4, 5, AND 11




Figure 5.1. Plan of Room Block 6. The profiles in Figure 5.2 correspond to the lines through the room block. The drawing is rotated slightly clockwise from the cardinal directions. Source: Cat. No. 2006.1.20.




Figure 5.2. Profiles of Room Block 6. Top: profile through Rooms 12, 11, and 5. Bottom: profile through Rooms 13, 18, and 4. Source: Cat. No. 2006.1.20.

Rooms 4, 5 and 11, in Room Block 6, were excavated in 1971. Figure 5.1 depicts these rooms and shows their positions relative to adjoining rooms in the room block. Figure 5.2 shows the profiles corresponding to Figure 5.1. Recorded locations for the rooms and their sub-datum vary, but maps show the block extending from 190 to 220N and from 020 to 060E. I assume that maps created in the field, during excavation, show the room block's location most accurately.

Room 4

1971 Excavation

James Judge led the 1971 excavation that identified Room 4, which had masonry walls and an adobe floor. Eight student notebooks (Cat. Nos.79.84.36, .38, .40, .41, .54, .57, .58, and .61) describe their work in the room from June 22 through July 7.

Data from Field Forms (Cat. No. 79.84.2)

Room Data Sheet. The sub-datum for this room was reported as being at 140N/040E, without a stated vertical relationship to the datum.

Most of the field forms show Room 4 in grid unit 140N/040E, but a few show the 140N crossed out and replaced with 190N. The room was a habitation room with four masonry walls (Table 5.1) and an adobe floor. Room fill was described as hard-packed at the top and soft near the floor.

The depths of the four corners of the room were recorded as 1.6 feet BSD (northeast), 1.45 feet BSD (southeast), and 1.65 feet BSD (southwest and northwest). These measurements were for the lowest (only) floor. A subfloor test was conducted to search for culturally sterile deposits.

Observations from Notebooks

The room was identified when a wall was found (Cat. No. 79.84.57). A test pit was started in the southwest corner of the room, where previous pot hunters had attempted to dig (Cat. No. 79.84.61).

Room walls became visible in the second level of fill (2B). The north wall of Room 4 was the south wall of Room 5. Room 4 had stonework that extended deeper than that in Room 5, and Room 4 appeared to be lower in elevation than Room 5 (Cat. No. 79.84.54). One sketch depicts rock and plaster walls (Cat. No. 79.84.38). One notebook suggests that the walls were rock on top of adobe (Cat. No. 79.84.61). The south, east and west walls appeared to be double masonry walls (Cat. No. 79.84.40) with fill between the rocks (Cat. No. 79.84.54).

The remains of an almost complete human foot were found in the northeast quadrant of the room (Cat. No. 79.84.36, .38), but it may not have been part of an "actual" burial (Cat. No. 79.84.38).

Summary of Excavation by Level

Table 5.2 summarizes the 1971 excavation of Room 4 by level, based on student notebooks. Only one field form entry is relevant here: the first floor (4A) was located at 1.45–1.64 feet BSD, was 0.5 foot thick, and was made of adobe (Cat. No. 79.84.2).

Excavation of the room was completed on July 7. On July 22 a student noted that Rooms 4 and 5 had been built before Rooms 11–13 and 18 (Cat. No. 79.84.61).

Data from Field Forms (Cat. No. 79.84.278A)

Room 4 was a habitation room in grid 140N/040E. The room was excavated to a depth of 1.7 feet BSD. A subfloor test was made in the northeast quadrant of the room, to a depth of 2.9 feet BSD where sterile was reached. Excavated levels included the first and second surface levels (1A, 1B), six levels of fill (2A–2F), and the first floor (4A). Level 1B was not mentioned on the 1971 field form or in student notebooks, but the Maxwell Museum has artifacts from that level.

Room 4 had masonry walls. The adobe floor (4A) measured 7.7 by 8.3 feet and was 1.7 feet thick (as was reported in 1971). An ash pit was present.

Room 4 appears on maps created in 1971 and from 1973 through 1976. All of the maps provide plan views; one 1971 map (Cat. No. 2006.1.20) provides a profile (Table A.2). Three maps (Cat. Nos. 79.84.236, 2005.25.15155, and 2006.1.20) place the room block in grid units 190–220N/020–060E.

Room 5

1971 Excavation

James Judge led the 1971 excavation of Room 5, which had adobe and stone walls and an adobe floor. Eight student notebooks (Cat. Nos. 79.84.36, .38, .41, .44, .54, .57, .58, and .61) describe work in the room from June 23 through July 7.

Data from Field Forms (Cat. No. 79.84.2)

Room Data Sheet. The sub-datum for this room was at 200N/040E, at 5.19 feet BD.

Room 5 was a habitation room with adobe and stone walls (Table 5.4) and an adobe floor. Room fill was hard-packed until the floor was reached, and soft-packed under the walls. The lowest (only) floor was reached and a subfloor test trench was placed. This test trench extended east of the room's east wall. Also, a test pit was placed in the northwest corner of the room. The test pit measured 2.85 feet north-south and 1.7 feet east-west. A pedestal was left in the southwest corner of the room.

The four corners of the room were all at 2.4 feet BSD. The test trench reached 4.2 feet BSD.

Grid Level Records. One form reports a fire pit in the north-central portion of the room and a test pit extending from 2.1 to 4.4 feet BSD in the northwest corner of the room. The test pit matrix consisted of very damp clay, charcoal, and hard clay at the bottom, with an ash lens.

Feature Forms. One form identifies a fire pit (F1) on the first floor (4A), 3.5 feet east of the room's west wall and 1.5 feet south of the north wall. The fire pit was level with the floor and had ash around its base. The fire pit measured 1 foot across and extended down about 0.2 foot. The fill was a white-gray puddle of ash with a concentration of burned bone, maize cobs, and sherds.

Observations from Notebooks

Room 5 was just north of Room 4, with a shared wall. The walls were double rows of stone with some adobe fill, and what appeared to be stone piled on top of a stone foundation (Cat. No. 79.84.61).

Room 5 was just east of Room 11, with a gap between the two rooms. The west wall of room 5 was not of the same material as the east wall of Room 11, which was adobe. (Cat. No. 79.84.38).

The students placed a test pit in the northwest corner of the room (Cat. No. 79.84.44). At the sixth level of fill (2F) in the test pit, they re-designated that level (2F) as the first floor (4A), based on a line of ash seen along the base of the test pit. A second, heavier line of ash appeared about 8 to 10 inches below the first. The first line of ash was level with the fire pit (Cat. No. 79.84.61).

Two notebooks mention finding abundant fill and refuse beneath the first floor (4A) and suggest that Room 5 may have been built over a midden (Cat. Nos. 79.84.38 and .61).

The students expanded and deepened the test pit and began a trench extending to the east part of the room (Cat. No. 79.84.38). They also extended the test pit all the way across (along?) the west wall (Cat. No. 79.84.61). According to one student, the test trench extended beyond the room and appeared "pretty sterile" (Cat. No. 79.84.58), while Room 5 was not.

Excavation of Room 5 ended on July 7. On July 22 a student noted that Rooms 4 and 5 were built before Rooms 11–13 and 18. (Cat. No. 79.84.61).

1974 Summary of Judge Excavation

Data From Field Form (Cat. No. 79.84.278A)

Room 5, used for habitation, was in grid unit 200N/040E. (It appears that this grid unit value was a mistake, and that the actual unit location was 150N/040E).

Five subfloor tests were placed in the room. The two surface levels (1A, 1B), five levels of fill (2A–2E), the first floor (4A), and two levels of fill below the first floor (5A, 5B) were dug to a depth of 2.4 feet BSD. The first floor (4A) measured 7.2 by 7.1 feet and was 2.4 feet deep. The floor was adobe with a fire pit, and the walls were adobe and masonry.

A piece of petrified wood was found on the first floor (4A). This may be the piece of petrified wood in the collections listed as coming from Test 1 at the first floor (4A-T1) (Table 5.6, below).

Artifacts, Photographs, and Maps in the Collections




Figure 5.4. Room 5, first floor (4A) with fire pit F1. Source: Cat. No. 80.24.534A.

Room 11

1971 Excavation

James Judge led the excavation that identified Room 11. Seven student notebooks (Cat. Nos. 79.84.36, .38, .40, .41, .57, .58, and .61) describe work in the room from July 1 through July 23.

Data from Field Forms (Cat. No. 79.84.4)

Room Data Sheet. The sub-datum for this room was reported as being at 150N/030E, without a stated vertical relationship to the datum.

Room 11 was used for habitation. The room fill was clay-like packed earth. A subfloor test was placed and indicated a possible second floor. Wall details are summarized in Table 5.7; wall heights were not recorded.

Depths of the four corners of the room were recorded as 2.25 feet BSD (northeast), 2.2 feet BSD (southeast), 2.1 foot BSD (southwest), and 2.1 foot BSD (northwest).

Grid Level Records. The record for the first level of roof fall (3A) includes a diagram of a grinding "box" (bin; F1) associated with the second level of fill (2B). Due to the sloping floor, the grinding bin (F1) and its associated manos were on, and recorded with, the first floor (4A).

The record for the first level of fill below the first floor (5A) identifies a stone-lined hearth.

Feature Forms. Two forms were recorded for a grinding bin (F1) located at 0.1 foot BSD. The first form places the grinding bin at grid location 159.5–161.N/030–033E; the second form places it at 159.55–162.7N/031.2–032.6E. The first form indicates that the grinding bin measured 3 by 1.9 feet, was filled with adobe, and was in the room's northwest corner. The second form indicates it measured 3.1 by 1.4 feet by 0.8 foot deep and was filled with hard-packed clay.

A feature form was recorded for a pit (F2) located at 1.6–1.9 feet BSD, at grid location 155.9–157.4N/035.9–037E. The pit measured 1.3 feet by 1 foot on the inside, was 0.3 foot deep, and was filled with light-colored ash with flecks of charcoal. The top layer of ash was darker and the lower layer was lighter in color and hard-packed. The pit was associated with a deflector north of the pit. The form also notes that depths were being measured from grid location 160N/030E.

Observations from Notebooks

Room 11 was west of Room 5. The west wall of Room 5 was built of different material than Room 11's adobe east wall (Cat. No. 79.84.38).

A diagram (in Cat. No. 79.84.38) shows the north wall of Room 11 as made of rock, and shows a gap between Room 11's east wall and Room 5's west wall. A different notebook (Cat. No. 79.84.40) indicates that the walls of Room 11 were all adobe except for a slight amount of masonry in the west wall. The east and west walls appeared to extend south to Room 12 (Cat. No. 79.84.61).

A small (1 foot) test was sunk in fill in the room's southeast corner (Cat. No. 79.84.61).

A notebook (Cat. No. 79.84.40) identifies a fire pit lined with stone slabs (F2), and indicates that in the south part of the room, the first floor (4A) was much smoother and flatter than in the north part of the room. The same notebook includes a diagram showing a test pit in the room's southwest corner, and describes finding what the students thought was a possible second floor. This possibility was later discounted, as the walls did not extend below the first floor (4A).

A notebook (Cat. No. 79.84.58) describes the fire pit (F2) as having stone slabs around it, and that a rock sticking out of the wall north of the fire pit was thought to be a deflector.

Summary of Excavation by Level

Table 5.8 summarizes the 1971 excavation of Room 11 by level.

1974 Summary of Judge Excavation

Data from Field Forms (Cat. No. 79.84.278A)

Room 11 was used for food processing and was in grid unit 200N/030E. Excavation included two levels of fill (2A, 2B), the first level of roof fall (3A), the first floor (4A), and the first level of fill below the first floor (5A), reaching a depth of 2.2 BSD. Subfloor tests were conducted.

The adobe first floor (4A) measured 9.4 by 6.7 feet and extended to 1.6 feet BSD. A grinding bin was found on the floor. The room walls were adobe and masonry.

The room had eroded enough to expose an adobe room below and offset from it.

Chapter 6

ROOM BLOCK 6, ROOMS 12, 13, AND 18

Rooms 12, 13, and 18, in Room Block 6, were excavated in 1971. The rooms are shown in Figures 5.1 and 5.2. As I describe in Chapter 5, the records show some confusion about the actual location of Room Block 6 and its sub-datum. Three maps (Cat. Nos. 79.84.236, 2005.25.15155, and 2006.1.20) place the room block in grid units 190 to 220N and 020 to 060E.

Room 12

1971 Excavation

James Judge led the 1971 excavation that identified Room 12. Eight student notebooks (Cat. Nos. 79.84.36, .38, .40, .41, .54, .57, .58, and .61) describe work in the room from July 7 through July 23.

Data from Field Forms (Cat. No. 79.84.4)

Room Data Sheet. Room 12 was used for storage. Room fill consisted of loose alluvial soil with burned roof beams and chunks of adobe. Excavation stopped at the first floor (4A). All four walls were plastered and burned. Table 6.1 provides additional wall details.

Depths of the room corners were recorded as 1.2 feet BSD (northeast), 1.25 feet BSD (southeast and southwest), and 1.3 feet BSD (northwest).

The room was identified as being in the north part of grid 150N/020E, just north of Room 13.

Grid Level Records. The room was reported as spanning grid units 150–160N/020E.

Observations from Notebooks

Beams in the roof fall (3A) had burned (Cat. No. 79.84.38).

One notebook (Cat. No. 79.84.61) described the walls as rock on top of adobe, and the charred roof beams as "huge."

Summary of Excavation by Level

Published Comments

The tree-ring date of 1313 from Room 12 was an "outside" tree ring date (Cordell 1977a:27). By 1975, the room had been excavated to sterile (Cordell 1977a:29).

1974 Summary of Judge Excavation

Data from Field Forms (Cat. No. 79.84.278A)

Room 12, a storage room, was in grid unit 200N/020E (which is consistent with several maps). Excavated levels included the first and second surface levels, the first and second levels of fill, the first level of roof fall, and the first floor (4A), reaching a depth of 1.3 feet BSD.

The burned adobe first floor (4A) measured 4.8 by 9.3 feet and was 1.3 feet deep. The room walls were adobe. Room 12 was contemporary with Room 13, as shown by their shared wall.

Room 12 yielded a tree-ring date of 1313r.

Room 13

1971 Excavation

James Judge led the 1971 excavation that identified Room 13. Seven student notebooks (Cat. Nos. 79.84.36, .40, .41, .44, .57, .58, and .61) describe work in the room from July 7 through July 23.

Data from Field Forms (Cat. No. 79.84.4)

Room Data Sheet. The sub-datum for this room was reported as being at 150N/020E, without a stated vertical relationship to the datum.

Room 13 was used for storage. The room fill was hard-packed in places, with chunks of burned adobe, burned wood, and charred maize cobs. The students could not determine whether the room was abandoned due to a fire or if the fire occurred after abandonment. The room was completely excavated. The lowest floor was found and a test pit continued down to sterile.

The east wall was burned and contained at least one viga. Other room details are provided in Table 6.4. It is not clear why some wall measurements are described as twelfths of a foot rather than inches.¹

Depths of the four room corners were recorded as 1.1 feet BSD (northeast and northwest), 1.45 feet BSD (southeast), and 1.4 feet BSD (southwest).

Grid Level Records. The south wall of the room was found just north of an unexcavated area with a tree on it, during excavation of the first level of roof fall (3A). All four walls were visible at first, but the south wall "faded out" at the first level of roof fall (3A).

Observations from Notebooks

Room 13 was reported to be in grid units 130N/020E and 140N/020E (Cat. No. 79.84.40).

The presence of manos plus the slab floor, along with the absence of a fire pit, suggested that Room 13 had been used for storage (Cat. Nos. 79.84.40 and .61).

Room 13 was backfilled on the last day of excavation (Cat. No. 79.84.57).

The students thought that Rooms 4 and 5 were built before Rooms 11–13 and 18 (Cat. No. 79.84.61).

Summary of Excavation by Level

Table 6.5 describes the excavations by level. A notebook entry states that the first floor (4A) consisted of stone slabs and adobe (Cat. No. 79.84.61).

¹ Judge may have instituted the use of measuring tapes marked in feet and tenths of a foot for fieldwork at Tijeras Pueblo. At the time, such tapes were standard issue among U.S. surveyors, engineers, and others, so widely available. In the resulting measurements, partial feet were expressed in decimal fractions. In the case of Room 13, and as a guess, we seem to have fractions of feet measured in inches (what the student grew up with) and recorded as fractions of feet (somewhat conforming to the system in use during fieldwork). —Series Editor

Published Comments

The Room 13 tree-ring date of 1321, obtained in 1975, was an outside tree-ring date (Cordell 1977a:27).

1974 Summary of Judge Excavation

Data from Field Form (Cat. No. 79.84.278A)

Room 13, a storage room, was located in grid unit 190N/020E (consistent with several maps). Excavation included the second surface level (1B), the first and second levels of roof fall (3A and 3B), and the first floor (4A), reaching a depth of 1.5 feet BSD. The field form indicates that the location of the test pit below the first floor was unknown, but that it was excavated to sterile. The first floor (4A) measured 7.8 by 6.3 feet, at a depth of 1.5 feet BD. The walls and floor were adobe.

A tree-ring date of 1321r was obtained but based on ceramic styles, the beams in Room 13 may have been recycled. Also, Room Block 6 may have been an outlying "farm" where food was processed.

Artifacts, Photographs, and Maps in the Collections

Table 6.6 summarizes the artifacts from Room 13 in the Maxwell Museum collections.




Figure 6.2. Room 13, jar on the first floor (4A). Source: Cat. No. 80.24.604A.

The Maxwell Museum archives include seven photographs of Room 13 (Table A.1). Figure 6.2 shows a jar on the first floor (4A).

Room 18

1971 Excavation

James Judge led the 1971 excavation that identified Room 18. Five student notebooks (Cat. Nos. 79.84.36, .40, .41, .57, and .61) describe work in the room from July 12 through July 22.

Room 18 contained a burial, which Stanley Rhine identified as Burial 12 (Cat. No. 73.106.7) (Judge 1974, Appendix C). According to Rhine's report, this burial was found in the first level of fill below the first floor (5A). The fragmentary remains were of an adult, possibly female, whose estimated height was 158 cm. In reviewing preliminary statements about the burial, included below, readers should keep Rhine's professional assessment in mind.

Data from Field Forms (Cat. No. 79.84.4)

Room Data Sheet. The sub-datum for this room was reported as being at 140N/030E, without a stated vertical relationship to the datum.

Room 18 was used for habitation. Room fill consisted of a mix of clay and sand with some charcoal, ash, and sherds and other artifacts.

A diagram shows a wall extending between the west and east walls, across the south part of the room (see Figure 5.1). Table 6.7 provides wall details.

Depths of the four corners of the room were recorded as 0.85 foot BSD (northeast), 1 foot BSD (southeast), 0.4 foot BSD (southwest), and 0.8 foot BSD (northwest). A note adds that these measurements may have been inaccurate due to rain.

A hearth (F1) was associated with the first floor (4A). A burial was found in the first level of fill below the first floor (5A). The burial lay above a second fire pit (see Figures 5.1 and 5.2).

Grid Level Records. Although the room data sheet identified the depth of the first floor (4A) as 0.9 foot BSD, the first floor grid level record identified its depth as 0.4 foot BSD.

The same grid level record (for 4A) indicates that Room $\underline{18}$ was built on top of an earlier room, and that a test pit extending from 0.6 to 1.9 feet BSD was placed in Room $\underline{18}$'s southeast corner. It also mentions a burial visible in the first level of fill below the first floor (5A), \underline{at} a hearth near the middle of the room.

Feature Forms. A form was recorded for the hearth (F1) at grid location 148.7N/032.5E and at 0.8 foot BSD. The hearth measured 1.5 by 1.8 feet, was 0.6 foot at its deepest point, was made with coarse stone, and was filled with ash. The form mentions that a burial was found to one side of, and below, fire pit F1 in association with an adobe fire pit, in the first level of fill below the first floor (5A).

Burial Form. A form for the burial places it in the first level of fill below the first floor (5A). The burial was associated with, or at least directly above, the hearth found on the second floor (4B). The primary interment was fully extended, with no grave goods, in soft loose ash with a matrix of hard-packed red clay. The remains were in fair condition but the skull, the lower legs, and the left arm were missing. Age was estimated at 18 to 22. The first floor (4A) plaster extended over the burial, with the body located between the first (4A) and second (4B) floors.

Observations from Notebooks

A burial of a female, possibly 11 years old, lacked wisdom teeth and had partially fused arm joints (Cat. No. 79.84.40). This burial had been placed on an adobe floor. A masonry wall extended through the burial where the lower legs would have been. A hearth had been placed where one arm would have been.

A different notebook indicated that the burial was found below and east of the first floor (4A) hearth, above a second hearth (Cat. No. 79.84.41). The burial was oriented with the missing head to the north. Surviving remains included vertebrae, the mandible, ribs, part of the pelvis, and toe or finger bones. Of the teeth, only two molars had survived, and those were ground down. The remains were surrounded by an ash lens (the burial pit fill?) and evidence of an adobe-walled fire pit or burial pit (Cat. No. 79.84.57).

A test pit was placed in Room 18's southeast corner (Cat. No. 79.84.41).

A double stone wall was present at the south end of the room (Cat. No. 79.84.41).

One notebook (Cat. No. 79.84.61) describes the room as a "puzzle," since it contained two walls in different levels (the second wall ended within the room's east and west walls) and two floor levels.

Summary of Excavation by Level

Table 6.8 summarizes the 1971 excavation of Room 18 by level. None of the notebook entries is relevant to this summary.

1974 Summary of Judge Excavation

Data from Field Form (Cat. No. 79.84.278A)

Room 18 was a habitation room in grid unit 190N/030E (a location consistent with several maps). The excavated levels included the second surface level (1B), three levels of fill (2A–2C), the first floor (4A), and the first level of fill below the first floor (5A) to a depth of 1.9 feet BSD (the same depth as the burial).

The first floor (4A) measured 8.7 by 8.0 feet, at a depth of 0.9 foot. The floor was hard-packed clay. The walls were adobe and masonry. A fire pit and a burial were found. The second floor (4B) also measured 8.7 by 8.0 feet (the depth was not given) and included a fire pit.

The first level of fill below the first floor (5A) was not completely excavated. Instead the focus was on the burial associated with the first floor (4A). (The reason for associating the burial with the first floor is not provided.) The presence of a subfloor burial overlying an adobe fire pit suggested the presence of an additional floor or floors beneath the first floor (4A).

The second masonry wall paralleling the south wall may have been part of a room built at a different time.

The second floor (4B) was not excavated.

Chapter 7

ROOM BLOCK 8, ROOM 130




Figure 7.1. Overview of work in Room Block 8. Source: Cat. No. 2005.25.15180.




Figure 7.2. Plan and profile of Room 130. Source: Cat. No. 2005.25.15180.

Linda Cordell led the 1976 excavation that identified Room 130 in Room Block 8. The room was first designated Room 123 but the room number was changed to 130. Documents and collections in the Maxwell Museum refer to both room numbers; in this chapter I present information according to the room number applied as records were created. Figure 7.1 provides an overview of the work in Room Block 8. Figure 7.2 shows Room 130.

"Room 123"

1976 Excavation

Three student notebooks (Cat. Nos. 79.84.225, .230, and .233) describe work in the room while it was designated Room 123, on three days between June 17 through July 2. None of the field forms in the Maxwell Museum Archives refers to the room as Room 123.

Observations from Notebooks

Room 123 was identified when the students found the room's first floor (4A) in grid unit 320N/320E (Cat. No. 79.84.230). A diagram in the notebook, drawn on the same day, shows the room number as 130. The room number is in red, suggesting that it was added after the fact.

A diagram (Cat. No. 79.84.225) shows two walls around the caliche first floor (4A) (Cat. No. 79.84.225).

On the last day of excavation, the room was designated Room 130 (Cat. No. 79.84.233).

Summary of Excavation by Level

One level was defined. According to a notebook (Cat. No. 79.84.233), the first floor (4A) was made of caliche. The matrix was a mix of brown soil, adobe, caliche, rocks, charcoal, and "chalk."

Artifacts, Photographs, and Maps in the Collections

Exposure of the first floor (4A) yielded sherds, stone artifacts, a bone awl, unworked bone, and eggshells.




Figure 7.3. "Room 123," first floor (4A). Source: Cat. No. 80.33.649A.

The Maxwell Museum Archives include two photographs of the room while it was designated Room 123 (Table A.1). Figure 7.3 shows the room's first floor (4A).

On two maps created in 1975 (Cat. No. 79.84.246) and 1976 (Cat No. 80.33.752), the number "123" is written in the corner of Room 43. However, Room 43 is in Room Block 1 and I do not know what "123" means on those maps. In Table A.9, I indicated that Room 123 was not a room.

Room 130

1976 Excavation

Six student notebooks (Cat. Nos. 79.84.205, .206, .212, .225, .230, and .233) describe work in Room 130 (under that designation) from June 18 through July 21.

Data from Field Forms (Cat. No. 93.16.1)

Room Data Sheet. The sub-datum for Room 130 was at 330N/330E, at 4.02 feet AD (above datum).

Room 130 was used for habitation. Room fill consisted of brown soil, hard adobe, and cobble footings. The lowest (only) floor was found. Excavation continued to sterile. Table 7.1 provides wall details.¹

Depths of the room corners were recorded as 4 feet AD (northeast), 3.58 feet AD (southeast), 3.87 feet AD (southwest), and 3.38 feet AD (northwest).

Feature Forms. A form was completed for a floor feature located at 3.2 feet AD, 2 feet from the room's southeast corner and 0.8 foot from the east wall. The feature measured 2.9 by 0.9 feet by 0.3 foot deep. The feature fill consisted of hard-packed adobe topped by two rocks. A semicircular gray coping suggested that the feature was a possible fire pit, but there were no ashes or other evidence that the feature was used to hold a fire.

¹ The shortest wall listed in Table 7.1 is the west wall, while the shortest one shown in Figure 7.2 is the southwest wall. Given this correspondence, the north wall probably equates to the northwest wall, the east wall to the northeast wall, and the south wall to the southeast wall. This is the sort of discrepancy that the author resolved during her usual revisions of edited drafts. —*Series Editor*

A form was completed for an adobe wall found at 4.02 feet AD, 0.9 foot below the surface, at 323–329.5N/324.5–330E. The wall was 7.9 feet long, 0.9 foot thick, and 0.3 foot high. The surrounding fill was adobe.

A form was completed for an adobe floor found at grid location 320–328.4N/327.5–330E, at 2.9 feet AD. The floor measured 9.5 by 7.9 feet.

Observations from Notebooks

One notebook (Cat. No. 79.84.230) explains that Room 130 was initially designated as Room 123 during the first half of the excavation effort. At the time the sub-datum used by the students was at 320N/330E, at 4.42 feet AD. Once the room was designated Room 130, the excavation proceeded using a sub-datum at 330N/330E, at 4.02 feet AD. This appears to explain why depth values in the field forms and student notebooks for Room 130 use both 4.42 and 4.02 feet AD as the vertical reference values for their work.

Room 130 was northwest of Room 129. The room fill was brown soil, hard adobe, and abundant roof fall and charcoal (Cat. No. 79.84.233).

Room 130, which was similar to Room 129, was diamond-shaped room with a corner pointed north (Cat. No. 79.84.225). The southwest wall was masonry (Cat. No. 79.84.206).

At the first floor (4A) the students started a 3 by 3 foot subfloor test, Test Pit 1 (T1), in the room's southeast corner (Cat. Nos. 79.84.225 and .230).

Summary of Excavation by Level

Chapter 8

ROOM BLOCK 8, ROOMS 129 AND 133-136

In 1976, Rooms 129 and 133–135 were excavated and Room 136 was at least partly exposed. All were in Room Block 8; their locations in the room block are shown in Figure 7.1.

Room 129

1976 Excavation




Figure 8.1. Plan and profile of Room 129. In the plan, North is to the left. Source: Cat. No. 2005.25.15180.

Linda Cordell led the 1976 excavation that identified Room 129, shown in Figure 8.1. Three student notebooks (Cat. Nos. 79.84.212, .216, and .224) describe work in the room from July 2 through July 21.

Data from Field Forms (Cat. No. 93.16.1)

Room Data Sheet. The sub-datum for this room was at 310N/340E, at 4.18 feet AD.

Room 129 was a storage room. The room fill consisted of adobe wash and roof fall. The lowest floor was found and excavation continued to sterile, found at 1.52 feet AD.

Table 8.1 provides wall details. A doorway in the southwest wall had been sealed.

Depths of the four corners of the room were recorded as 3.68 feet AD (north), 3.78 feet AD (east), 3.83 feet AD (south), and 3.98 ft AD (west).

Grid Level Records. At the first level of fill (2A), most of the wall fall from the northeast wall was outside the room.

Feature Forms. A "possible" floor (F1) was found at 2.96 feet AD. This feature measured 8.25 by 7.25 feet and was 0.1 to 0.2 foot thick. The associated fill was very hard-packed adobe wash, abundant ash, and charcoal.

The actual first floor (4A) was found at 2.52 feet AD. It had the same dimensions as the possible floor (8.25 by 7.25 feet) and was 0.1 foot thick.

A post hole (also F1) was found on the second floor (4B), at 2.68 feet AD (1.5 feet below the surface), 1.2 feet from the northwest wall and 4.5 feet from the northeast wall. The post hole measured 0.3 by 0.2 foot and was "gourd shaped."

An ash lens (F2) was also associated with the second floor (4B). The ash lens was found at 2.58 feet AD, 2.3 feet from the northwest wall and 2.9 feet from the northeast wall. The lens measured 1.5 by 1.5 feet. The lens was resting on the floor, but the floor was not burned.

¹ In this chapter, I have modified the recorded orientations for walls and room corners to conform with the plan views. For Room 129, for example, the north wall in the records is now the northwest wall. Observations from Notebooks

Room 129 was in grid unit 310N/330E, and was angled such that one corner pointed north. The wall west of that corner was adobe; the one to the east of the corner was masonry (Cat. No. 79.84.224).

A doorway in the middle of the southwest wall was plugged with rough stones and adobe (Cat. Nos. 79.84.212 and .216).

A post hole, surrounded by hard adobe wash and an ash lens, was found in the room's south corner. The post hole was 2.2 feet from the southwest wall and 2.1 feet from the southeast wall (Cat. No. 79.84.212). This does not appear to be the post hole labeled F1 and associated with the second floor (4B).

The information on the depths of the first and second floors (4A, 4B) is inconsistent. The room data sheet indicates that the first floor (4A) was found at 1.56 feet BSD and that the second floor (4B) was found at 1.76 feet BSD. A grid level form, prepared at a later date, changes the floor depths to agree with those provided in two notebooks (Cat. Nos. 79.84.212 and .224). According to the notebooks:

- Initially a first floor (4A) was identified at 2.96 feet AD. This floor was associated with three ash pits and a stone slab. The matrix (floor fill?) was soft dirt with rodent burrows and soft adobe, possibly roof fall.
- The students changed the designation for the layer from first floor (4A) to first level of roof fall (3A). This happened as they dug below a stone slab next to the room's south wall and identified the actual first floor (4A). They also identified a second floor (4B), immediately below the actual first floor (4A).
- A test pit started in the north corner of the room was abandoned when the floors were found.

Summary of Excavation by Level

Published Comments

Room 129 had crude masonry wall footings (Cordell 1977b:184).

The room was found along with Room 130 while excavating a 3 by 10 foot trench (Simon, in Cordell 1977b:227).

The two identified tan adobe floors were highly eroded, and were separated by 0.01–0.3 foot (Simon, in Cordell 1977b:228).

Room 133

1976 Excavation




Figure 8.3. Plan and profile of Room 133. In the plan, north is to the left. Source: Cat. No. 2005.25.15180.

Linda Cordell led the 1976 excavation of Room 133, shown in Figure 8.3. Five student notebooks (Cat. Nos. 79.84.205, .212, .214, .230, and .235) describe work in the room from July 1 through July 12, with an additional brief mention of the room in one notebook on July 21.

Room Data Sheet. The fill of Room 133 consisted of adobe wash, charcoal, and ash. A single adobe floor (4A) was found; excavation continued to sterile at 0.17 foot AD. Table 8.4 provides wall details.

Depths of the four room corners were recorded as 1.97 feet AD (northeast), 1.57 feet AD (southeast), 0.87 foot AD (southwest), and 1.57 feet AD (northwest).

A burial (B1) found in Test Pit 1 (T1) was associated with the floor (4A).

Grid Level Records. The east wall, part of the north wall, and the northeast corner of the room were visible at grid location 270N/350E, in the first surface level (1A).

Test Pit 1 (T1) was in the grid unit's northeast corner; part of the room's east wall lay within the test pit. A fragment from a human infant's skull was found in T1's northeast corner, outside the room. (If this last piece of information is correct, it is not clear why the students associated the skull fragment with the first floor.)

Feature Forms. The first floor (4A) had an average depth of 1.1 feet BSD and measured about 10 by 4.7 feet.

Burial Forms. Burial (B1) was found in the northeast corner of Test Pit 1 (T1). The burial was found at grid location 267.8N/351.4E, at 1.1 feet BSD, and was associated with the first floor's (4A) subfloor. The burial was disturbed. The fill immediately around the burial included adobe and brown soft soil. The surrounding fill consisted of packed brown soil.

The sub-datum for Room 133 was at 260N/350E, at 2.07 feet AD.

Observations from Notebooks

The room was identified in grid unit 260N/340E (Cat. No. 79.84.235).

At the first floor (4A) level, walls appeared to continue beyond the room's adobe northwest corner (Cat. No. 79.84.205). The same notebook indicates that sherds in the room contained a large proportion of mica temper, unlike sherds in the rest of the rooms in the room block.

Test Pit 1 (T1) was excavated in the room's northeast corner. An infant burial (B1) was found at the first floor (4A) level and identified as B48. A piece of the cranium was embedded in the room's north wall and a few adult bones were found in the east wall (Cat. Nos. 79.84.205 and .214). A diagram (in Cat. No. 79.84.205) indicates that the burial included a skull fragment, a long bone, ribs, a possible arm bone, and some highly decomposed bones. Another notebook (Cat. No. 79.84.235) adds that the occipital portion of the skull was "somewhat intact," that four

rib fragments was found, that an adult rib fragment was found very close to the room's northeast corner, and that near the burial (B1) were segments of a subfloor that may have sunk when the burial was made beneath the floor.

Summary of Excavation by Levels

Published Comments

In 1976 a trench was dug along existing walls of other rooms in the room block, revealing Room 133. The crew thought that Room Block 8 may have included as many as 12 rooms (including Rooms 129, 130, and 134–136 in the north part of the mound; Room 133; and unidentified rooms in the south part of the mound) (Simon, in Cordell 1977b:227). (However, the field records do not identify any rooms other than Rooms 129, 130, and 133–136).

Room 133 may have been used for storage. The first floor (4A) was pink to gray to white adobe along the north edge of the room, without any features (Simon, in Cordell 1977b:229).

Burial B48 was either fetal or newborn (Weaver, in Cordell 1977b:208, Simon, in Cordell 1977b:229).

1976 Excavation




Figure 8.5. Plan and profile of Room 134. Source: Cat. No. 2005.25.15180.

Linda Cordell led the 1976 excavation that identified Room 134, shown in Figure 8.5. Eight student notebooks (Cat. Nos. 79.84.205–.207, .212, .216, .227, .230, .233) describe their work in the room from July 6 through July 21.

Data from Field Forms (Cat. No. 93.16.1)

Room Data Sheet. The sub-datum for this room was at 319.7N/322.9E, at 3.9 feet BD.

Room 134 was used for making pottery, based on evidence of raw material storage and manufacturing. The room fill was adobe in the south end of the room and loose brown soil in the north end. The lowest (only) floor was found and excavation continued to sterile.

The first floor (4A) was found only at the southwest end of the room, extending north about 2.5 feet.

Two burials were found. Burial 1 (B1) was in the second level of fill below the first floor (5B), 1 foot below the first floor (4A). Burial 2 (B2) was in the second level of fill below the first floor (5B) in Test Pit 1 (T1), 1.5 feet below the first floor (4A).

Depths of the four room corners were recorded as 0.15 foot BSD (northeast), 0.95 foot BSD (southeast), 1.2 feet BSD (southwest), and 0.4 foot BSD (northwest).

Grid Level Records. Room 134 was categorized as a storage unit at the first level of fill (2A).

The first level of fill below the first floor (5A) was adobe and clay and included multiple pockets of ash. Indications of pottery making seemed to continue into the second level of fill below the first floor (5B).

Feature Forms. The first floor (4A) measured 2 by 2 feet and was 0.08–0.1 foot thick. This patch of floor was in the room's southeast corner, near grid location 320N/320E.

A paper-thin ash lens (F1) was found at 1.9 feet AD (1.2 feet below the surface), 1.2 feet from the west wall and 1.0 foot from the south wall. The ash lens measured 1.6 by 1.4 feet.

Burial Forms. Burial 1 (B1) included an infant skull found at grid location 318.5N/318E, at 2.55 feet BSD (0.5 foot below the first floor [4A]). The interment fill was clay; the surrounding fill was clay and loose brown soil. The bones were brittle, fragmentary, and disarticulated.

Burial 2 (B2) included an adult skull found at grid location 319N/320.5E, at 3.9 feet BSD. B2 was associated with the third and fourth levels of fill below the first floor (5C, 5D). The head of the burial was oriented to the east. This burial included two pieces of pottery: a plainware sherd completely covered the face, and a redware sherd lay in front of the chest. B2 was found 0.5 foot below B1 and 1.5 feet below the first floor.

Observations from Notebooks

At first, the sub-datum for the room was at 320N/320E, at 3.4 feet AD. A few days later, the sub-datum was changed to 319.3N/322.9E, at 3.9 feet AD (Cat. No. 79.84.207).

The infant burial (B1) was identified as fetal. It included skull fragments, teeth (canine, incisor, primary molar), vertebrae, and a rib (Cat. Nos. 79.84.206 and .227).

A notebook (Cat. No. 79.84.206) states that the second burial (B2) was found in the third level of fill below the first floor (5C) in Test Pit 1 (T1), at 0.5 foot AD. It was an adult female in a flexed position on its right side, with an innominate missing the hyoid and coccyx. B2 was aligned eastwest and was in good condition. The ends of the long bones were crumbly. B2 was underlain by red clay.

Test Pit 1 (T1) measured 3 by 3 feet and was placed in the south end of the room (Cat. No. 79.84.307).

Summary of Excavation by Level

Depth designations in Room 134 are confusing. The room data sheet lists the sub-datum for the room as being at 319.7N/322.9E, at 3.9 feet, without stating whether this measurement was above datum (AD) or below datum (BD). The notebooks provide a variety of depths with both AD and BSD designations (Table 8.8). One notebook (Cat. No. 79.84.206) lists the first floor (4A) as being located at 2.4 to 1.9 feet AD, 1.5–2.0 feet BSD, with the sub-datum being 3.9 feet AD and the "new" sub-datum rebar placed at 319.3N/322.9E. The notebook goes on to explain that the sub-datum was moved to allow readings within a trench, since a rock wall stood between the original sub-datum and the trench.

Published Comments

Room 134 was found during excavation of 4 by 4 foot test pits (Simon, in Cordell 1977b:227).

Cordell (1977b:200) described the walls of Room 134 as adobe, with crude masonry footings; Simon (in Cordell 1977b:230) described them as masonry. Figure 8.5 indicates that Simon's description is correct. A non-cutting date of AD 1313vv was obtained from wood associated with the first floor (4A) (Cordell 1977b:184).

The room was small (3.5 by 9 feet). At one time it may have been divided in half by a line of stones spanning the room's shorter axis. It had a gray adobe floor covering the area south of the stone line. The room may have been a pottery production area, as it contained unfired and fired clumps of clay, a small piece of unattached red slip, polishing stones, and a piece of raw gypsum "temper" (Simon, in Cordell 1977b:230).

Burial 1 (B1) was an infant of less than 6 months (its lab number was B50).

The published reports on Burial 2 (B2) are inconsistent. Weaver (in Cordell 1977b:209) identified it as a 40 year old male (lab number B51). Simon (in Cordell 1977b:230) identified it as a female, as did a student notebook (Cat. No. 79.84.206). My review of the Maxwell

Museum's osteology records located a general skeletal inventory form for the burial that reports it to be male.

Artifacts, Photographs, and Maps in the Collections

Room 134 appears on a 1976 map (Cat. No. 2005.25.15180) that provides both a plan view and a profile (Table A.2).

Room 135

1976 Excavation




Figure 8.7. Plan and profile of Room 135. In the plan, North is to the left. Left to right in the profile corresponds to West to East in the plan. Source: Cat. No. 2005.25.15180.

Linda Cordell led the 1976 excavation that identified Room 135, shown in Figure 8.7. Eight student notebooks (Cat. Nos. 79.84.205, .206, .207, .212, .225, .227, .230, and .233) describe their work in the room from July 15 through July 22.

Data from Field Forms (Cat. No. 93.16.1)

Room Data Sheet. The sub-datum for this room was at 310N/330E, at 3.98 feet AD.

Room 135 was possibly used for ceremonial purposes. The room fill consisted of hard-packed adobe with signs of a burned and fallen roof. The lowest floor was found and excavation continued to sterile, which was encountered at 0.48 foot AD.

Table 8.10 provides wall details. Depths of the four room corners were recorded as 0.2 foot BSD (northeast), 0.6 foot BSD (southeast), 1.35 feet BSD (southwest), and 0.5 foot BSD (northwest).

Grid Level Records. The first floor (4A) was made of gray adobe. The measurements on the grid level form differ than those in Table 8.10. The north edge of the floor was listed as 7.7 feet long, the east as 7 feet long, the south as 8.5 feet long, and the west as 7.1 feet long.

The first floor (4A) was associated with five features; an ash/fire pit (F1), a masonry deflector (F2), ladder holes (F3 to the north, F4 to the south), and an adobe-lined hole found under the first floor (F5).

Observations from Notebooks

The room was in grid unit 310N/320E. It was diamond-shaped with corners to the north, south, east and west (Cat. No. 79.84.227).

One notebook (Cat. No. 79.84.227) places Test Pit 1 (T1) in the room's north corner.

A diagram (in Cat. No. 79.84.212) shows two masonry walls that formed a rectangular enclosure with the room's south corner (Cat. No. 79.84.212).

The room was slightly higher in the north than in the south (Cat. No. 79.84.206).

Published Comments

A non-cutting date of 1351vv was obtained from the first level of fill below the second floor (6A) in Test Pit 1 (T1). A cutting tree ring date of AD 1305 was obtained from wood from an isolated wall and corner segment exposed south of the room (Cordell 1977b:184, 200).

Simon (in Cordell 1977b:230-231) provided descriptions of "atypical" floor features which at times are inconsistent with those in Table 8.11:

- A circular ash/fire pit in the center of the southern half of Room 135 measured 1.5 feet in diameter, was surrounded with an adobe coping, and was lined with stone slabs.
- A 4 foot long segment of masonry (possibly a room divider), with adobe mortar, was found southeast of the ash/fire pit. The wall segment paralleled the room's southeast wall and connected with the southwest wall at a right angle.

- Three small circular holes were found northwest of the ash/fire pit. They measured 0.2 to 0.5 foot in diameter, and were at oblique angles to the floor but not post holes.
- A cluster of sandstone slabs in the room's west corner possibly served as a series of bases for a roof or wall support post.
- A second floor (4B), of gray adobe, was found in a test pit in the room's north corner. Its proximity to the first floor (4A) suggests a remodeling episode. Below the second floor, in the second level of fill in Test Pit 1 (6B-T1), were two distinct ash lenses.

Room 136

1976 Excavation




Figure 8.9. Plan and profile of Room 136. In the plan, north is to the left. Source: Cat. No. 2005.25.15180.

Linda Cordell led the 1976 excavation that identified this room, shown in Figure 8.9. Three student notebooks (Cat. Nos. 79.84.205, .212, and .233) describe work in the room on July 20 and 21. No field forms were found for Room 136.

Observations from Notebooks

One notebook (Cat. No. 79.84.233) states that Room 136 was not excavated.

A diagram (in Cat. No. 79.84.205) shows a fire pit near the room's east wall. A diagram in a different notebook shows the room as having four masonry walls, a fire pit near the room's southeast wall, and two burials in the grid unit directly south of the east half of the room (Cat. No. 79.84.212).

Published Comments

Room 136 had adobe walls with crude masonry wall footings (Cordell 1977b:184).

In 1976, based on wall lengths in Rooms 129 and 130, 4 by 4 foot test pits were excavated in search of additional room corners. The effort resulted in the identification of corners for Rooms 134–136 (Simon, in Cordell 1977b:227).

A trench in grid unit 300N/331E crossed two rooms, identifying masonry cross walls and separate floors in the north and south halves of the trench. The floor in the north half of the trench was associated with Room 136 and included a fire pit made of stone slabs and adobe (Simon, in Cordell 1977b:231).

Artifacts, Photographs, and Maps in the Collections

The Maxwell Museum does not hold any artifacts or photographs from Room 136. A 1976 map (Cat. No. 2005.25.15180) provides a plan and profile of the room.



Chapter 9

THE LARGE KIVA




Figure 9.1. The large kiva. Source: Bertram and Cordell n.d.

In the last few days of the 1975 UNM field school, a large exterior kiva was identified (Figure 9.1). The structure was not fully excavated or given a room number. It was frequently referred to as a "Great Kiva." By any name, it must have been a structure used by one or more groups with widespread membership in the village.

Information about the testing of the large kiva comes from documents by Linda Cordell and others, from student notebook entries for the excavation of units in the area, from photographs and maps, and from artifacts from grid units where the large kiva was located. The format of this chapter is consequently somewhat different than that for excavated numbered rooms.

1971 Field Season

The 1971 excavation at Tijeras Pueblo, led by James Judge, included work in the area later identified as including the large kiva. This work spanned grid units 250–350N/075–150E (Cat. No. 79.84.205), with its center at 300N/100E (Cat. No. 79.84.206), and included surface collection and minimal excavation. Six student notebooks (Cat. Nos. 79.84.36, .38, .44, .54, .58, and .61) describe work in the grid units from July 9 through July 25.

Observations from Notebooks

Table 9.1 summarizes the students' findings in the area where the large kiva would later be found.

One notebook (Cat. No. 79.84.61) mentioned finding stone tools (choppers, scrapers, and a broken mano) in grid units surrounding grid point 270N/120E.

Artifacts in the Collections

The Maxwell Museum collections include artifacts collected from the local portion of the site grid in 1971 (Table 9.2). Some were found by the same students whose notebooks are cited in Table 9.1; any artifacts that appear to be duplicates of those mentioned in Table 9.2 are not included in Table 9.2. A few artifacts in the collections come from bags that did not list excavator names and that cannot be traced to any of the student notebooks.

1973 Excavation

James Judge led the 1973 excavation at Tijeras Pueblo. A few artifacts in the Maxwell Museum collections come from the area of the large kiva and were collected in 1973. These came from the surface of grid unit 300N/100E and included sherds, a possible mano fragment, additional ground stone, and a scraper. One student (Cat. No. 79.84.127) reported working in the area on July 19 and 20.

1974 Excavation

The 1974 excavation at Tijeras Pueblo, led by Linda Cordell, included surface collection of a few sherds in the area of the large kiva (Bertram and Cordell n.d.:1). However, the Maxwell Museum collections do not include artifacts collected in 1974 from the area, and none of the student notebooks from 1974 describes work in grid units 250–350N/075–150E.

1975 Excavation

Linda Cordell led the 1975 excavation that identified the area near Mera's Mound I as a "great kiva" measuring 45 feet in diameter, with double-coursed masonry walls about 1.7 feet thick (Cordell 1977a:25). Nine student notebooks (Cat. Nos. 79.84.179, .180, .187, .189, .191, .193, .194, .197, and .202) describe work in grid unit 270N/100E from July 9 through July 25. Three notebooks (Cat. Nos. 79.84.180, .193, and .194) mention working along the trench (T1) dug from about 270 to 350N, along 100–101E. Table 9.3 summarizes the artifacts in the Maxwell Museum collections obtained from T1 in 1975.

Observations from Notebooks

Work on the area became more focused on July 17. One notebook mentions that the student worked with Jack Bertram that day to develop a methodology to explore grids 270–350N/100E, to look for signs of agriculture and watering systems. The students identified a rock structure possibly used for water control (Cat. No. 79.84.180).

The students excavated a masonry feature that appeared to be a wall. The feature's south face was a very even surface of rectangular rock slabs. A large section of adobe was also found. The north side of the feature appeared to be wall fall above abundant clay (Cat. No. 79.84.197).

The students dug a trench extending from 270N through 350N (marked "A" in Figure 9.1) and found a wall at a second stone concentration (near "B" in 9.1) (Cat. No. 79.84.179). The south face of the rock structure was a coursed masonry wall and the north side resembled a pile of wall fall (Cat. No. 79.84.180).

In clearing the masonry wall, the students found abundant adobe, eroded mortar, and hard clayey soil, the last including abundant chunks of material with caliche (Cat. No. 79.84.179).

The structure extended from about 330N to 295N at its southern boundary, and was at least 3 feet deep. A visiting archaeologist suggested that it might have been a water reservoir for domestic use (Cat. No. 79.84.180).

Trench 1 (T1) was dug using a backhoe, extended 80 feet north-south, and was 3 feet wide. The students noticed a vegetation change in the area where the trench was sunk, indicating that the soil was disturbed. The soil was orange-brown, sandy, with finer soil in the south end of the trench (Cat. No. 79.84.189).

A second trench (T2) was dug on the next to last day of the field school, and a surface with wood was found between the two trenches (T1 and T2) (Cat. No. 79.84.187). A possible floor was identified about 8 feet south of rubble in the north end of Trench 1 (T1). Tree-ring samples were collected (Cat. Nos. 79.84.187, .189, and .202). Trench 1 (T1) was 80 feet long and 2 feet wide, and was at 270–350N/101E (Cat. No. 79.84.193).

On the last day of the UNM field school, one student indicated that the area might be a "big kiva" instead of an agricultural field (Cat. No. 79.84.202).

1976 Excavation

Linda Cordell led the continuing excavation of the area in 1976. Five student notebooks (Cat. No. 79.84.205, .206, .227, and .230; Cat. No. 2005.25.15123) mention excavation work in the area of the "great kiva" from June 7 through June 24.

Observations from Notebooks

One notebook (Cat. No. 79.84.227) mentions that excavations were occurring in the area of 300–320N/320–340E in June 1976, which included the 300N gridline of the "great kiva."

A second notebook (Cat. No. 79.84.230) indicates that one of the objectives of the 1976 UNM field school was to map the "great kiva" using electronic devices.

The inside cover of a notebook (Cat. No. 79.84.205) includes a diagram of the "great kiva" and shows its location as 250–350N/075–150E.

A different notebook diagram (Cat. No. 79.84.206) places the center of the "great kiva" at grid location 300N/100E.

The final notebook (Cat. No. 2005.25.15123) suggests there might have been a series of room blocks around the "great kiva".

Published Comments

The area with the large kiva was about 300 feet north of the pueblo's main mound and was first thought to be some form of water or soil control feature. The surface in that area included a line of exposed masonry that was later identified as the south part of a wall. A single backhoe trench, oriented north-south and about 2 feet deep, was dug through the feature (Bertram and Cordell n.d.:1).

Once the crew realized that the feature was circular, pits were dug along the extrapolated perimeter in search of walls. The double-coursed masonry wall thus exposed measured 1.5 to 1.9 feet thick, with an average thickness of 1.7 feet. At a point at the south end of the feature, the buried wall measured 3.8 feet high. At a point at the north end, the wall was 4.6 feet high. At both points, about 0.5 foot of the measured height consisted of wall footings. The wall fall at the south end suggested that the original wall rose about 7.5 feet high above the footing. The structure was not semi-subterranean and its material had not been robbed for later construction (Bertram and Cordell n.d.:2).

A possible floor was located at a depth of 4 feet. The floor was poorly defined. Patches of burned clay, charcoal, and fragments of burned wood were overlain by a 0.1 foot thick lens of loose sandy soil. The wood fragments may have been latillas. Fragments of wood were sent to the treering laboratory at the University of Arizona (Cordell 1977:25).

Pits were dug at various points penetrating along the structure's circular wall (Figure 9.1). The exposed masonry was described as "excellent by P. IV Rio Grande standards"; it consisted of double-coursed masonry without a rubble core. The crew found some chinking using small pebbles. The mortar was hard pure clay. About 85 percent of the wall volume was stone (Bertram and Cordell n.d.:2).

The students recovered a few sherds along the circular wall and from the trench that crossed the interior of the structure. Excavation was incomplete and no kiva-like features were identified. Unusually large rubble concentrations were found ESE and SSW of the structure's center, suggesting that antechambers may have been present (Bertram and Cordell n.d.:3).

The crew conducted subsurface mapping using electronic resistivity equipment to map the "great kiva" instead of excavating it. A Ph.D. anthropology student with an academic emphasis in geology supervised the work using equipment from UNM's Geology Department. Results were "encouraging but limited" since the equipment was only available for two days, and was only used to locate the "great kiva" walls (Cordell 1977a:191).

A tree ring date of 1313vv was obtained from a sample found in grid unit 310N/100E, in Trench 1 (T1) (Cordell 1977a:199). A comment included in Table A.6 suggests that a sample sent for tree-ring dating may have come from a roof support.

Photographs and Maps in the Maxwell Museum

The Maxwell Museum Archives include nine photographs of Trench 1 (T1) in grid 270N/100E. These show the excavations in the trench that led to the identification of the large kiva. Figure 9.2 shows Trench 1 (T1) and the partly exposed kiva wall.

Chapter 10

DISCUSSION

The excavations at Tijeras Pueblo in the 1970s were conducted in a rigorous manner. They took place at the beginning of the modern computer era, when archaeological data were destined to reside in electronic form. Consequently, attempts were made to standardize the process of collecting and recording data.

There are many discrepancies in the reported data, and at times I wished I had been in the room as discussions were held about how to identify an artifact or specify where it was found. Even so, the fact that so much information was collected and recorded in a systematic way made this report possible.

The report incorporates much of the information from the 1970s excavations now in the Maxwell Museum's collections and archives. My goal was to provide a room by room description of the work done at the site; other aspects of the fieldwork (extramural testing, for example) are not detailed in this report. Because so much emphasis was given to excavating rooms, the room by room review will give readers a sense of the excavation as a whole.

One reason that the excavations from 1948, 1968, and 1986 are not covered by this report is the lack of equally systematic data from those excavations. Rooms were identified but not shown on maps. Mention was made of a kiva being in some unidentified room. Maps did not exist for some work, and other efforts did not distinguish between rooms and areas identified only as features. The existing notes are not sufficient to identify which room was being excavated or where it was located. We do know that some of the 1948 excavation occurred in Room Blocks 1–5, but we cannot identify which rooms were dug. I can only assume that some of those rooms were reexcavated in the 1970s.

At the end of the 1970s excavations, most of the rooms were backfilled. They remain covered over behind the Tijeras Ranger Station. The site is open to visitors and includes an interpretive trail. An active Friends association maintains an interpretive exhibit and education programs in a building a stone's throw from the site.

The crews working at Tijeras Pueblo in the 1970s initially identified 143 rooms. As Table 10.1 shows, the final count was 138 to 140 rooms. Table 10.2 summarizes various aspects of those rooms. In a few instances it was not clear if the crew decided whether a floor had been found or even if the feature was a room. Many rooms were designated as having more than one function due to uses associated with different floors, due to conclusions reached in different years, or simply due to multiple functions identified in different source materials.

Table 10.3 summarizes the assignments of room functions. The only common single function rooms were habitation and storage rooms (as is common in Ancestral Puebloan sites). Thirty excavated rooms were not assigned a function. The only unexcavated room assigned a function was the "great kiva"; in that case the assigned function was based on the feature's size and shape.

Three of the kivas included in Table 10.3 were fully excavated (Rooms 64, 108, and 128). As I discuss in Chapter 9, the large exterior kiva (often referred to as a "great kiva") was only tested. The rooms identified as ceremonial in Table 10.3 were not the same rooms as the kivas.

Table 10.4 identifies the counts of rooms and other features in various source materials at the Maxwell Museum. The counts include rooms that were later redefined.
